


CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR





AN ACT AUTHORIZING THE GOVERNOR OF GUAM TO
RESERVE APPROXIMATELY THIRTY-TWO (32) ACRES OF
GOVERNMENT OWNED PROPERTY IN THE INARAJAN
SUBDIVISION FOR RECREATIONAL AND EDUCATIONAL
PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM;

2 Section 1. Section 13965.2 of the Government Code is
3 amended to read:

4 "Section 13965.2. Transfer to Guam Housing and Urban
5 Renewal Authority. Notwithstanding any other provisions
6 of law, the Governor shall convey from the government of
7 Guam to the Authority subdivisions defined in Section 13965.1
8 of this Chapter. Provided, however, that the Governor shall
9 reserve for the government of Guam only such property as
10 is reasonably required for the public school now existing
11 in the Inarajan subdivision. Provided, however, that the
12 Governor shall reserve for the government of Guam approxi-
13 mately thirty-two (32) acres adjacent to the Inarajan
14 Junior High School in Lot 554-R2, land square 37, Section 1,
15 as shown in Drawing JCTA-S-00-3-78 and recorded in the
16 Department of Land Management, government of Guam, on May 11,
17 1979 under Document 302215."
