

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT APPROPRIATING SIXTY THOUSAND DOLLARS
(\$60,000) FROM THE TOURIST ATTRACTION FUND
TO THE DEPARTMENT OF PARKS AND RECREATION
FOR THE PURPOSE OF RENOVATING THE INARAJAN
POOL.

1 WHEREAS, the Inarajan Pool is a major tourist attraction
2 and recreational area for both the local residents and visitors
3 to our island; and

4 WHEREAS, the people of Inarajan through fund raising efforts
5 have developed the pool; and

6 WHEREAS, with certain improvements, the Inarajan Pool and
7 its surrounding seashore can be the most beautiful scenic park
8 swimming area of the south; and

9 WHEREAS, frequent pollution of the pool have caused concern
10 for the health of those people using the pool; now, therefore,

11 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

12 Section 1. The sum of Sixty Thousand Dollars (\$60,000) is
13 hereby appropriated from the Tourist Attraction Fund to the
14 Department of Parks and Recreation for the renovation of the
15 Inarajan Pool.
