



CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT TRANSFERRING UP TO FIVE (5) ACRES
OF GOVERNMENT LAND TO THE DEPARTMENT OF PARKS
AND RECREATION FOR CONSTRUCTION OF A BASEBALL
FIELD, TENNIS COURT OR MULTI-PURPOSE COURT IN
MALOJLOJ.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. The Department of Land Management shall
3 designate up to five (5) acres of government land located in
4 Malojloj which shall be transferred to the Department of Parks
5 and Recreation for construction of a baseball field, tennis court
6 or multi-purpose court. Once the real property is identified,
7 the Department of Public Works shall estimate the cost of cons-
8 truction of a baseball field, tennis court or multi-purpose
9 court and advise the Governor and the Legislature of the cost
10 and anticipated length of time required for construction.
