AN ACT AUTHORIZING THE EXPENDITURE OF FEES FOR LOST BOOKS.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAN:

Section 1. A new Section 11126 is added to the Government

Code to read:

"Section 11126. Lost Books. Funds received by schools as fines for lost books shall be deposited in the 'Lost Book Fund' which shall be kept separate from other funds of the government. The Board of Education may expend money from the 'Lost Book Fund' to purchase new textbooks and replace lost textbooks. The Board shall report to the Legislature no later than June 30 of each year of the total amount of fines collected by the department and the income and disbursements from the Lost Book Fund. The Director of Education shall be the certifying officer of the Lost Book Fund. The Director of the Bureau of Budget and Management Research. shall be the custodian of the Lost Book Fund." Section 2. This Act shall become effective October 1, 1982.
