
CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT TO AMEND PUBLIC LAW 16-44 FOR THE
PURPOSE OF APPROPRIATING FUNDS FOR THE

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. Item (C) of Part XXVII of Section 3 of Public
Law 16-44 is amended to read:

None of the funds appropriated to the Office of the Territorial Prosecutor in Part XLIV of Section 3 of this Act shall be expended for the purpose of leasing office space in any building owned or managed by an elected official of the government of Guam or in which an elected official has a substantial proprietary interest."
