

CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR



AN ACT TO REPEAL SECTION 1020 AND TO ADD A  
NEW SECTION 42020 OF THE GOVERNMENT CODE TO  
DESIGNATE THE NIEVES FLORES MEMORIAL LIBRARY  
AS THE TERRITORIAL DEPOSITORY FOR ALL  
GOVERNMENTAL DOCUMENTS OF THE GOVERNMENT  
OF GUAM, AND FOR OTHER PURPOSES.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. Section 1020 of the Government Code is repealed.

3 Section 2. A new Section 42020 is added to the Government Code to  
4 read:

5 "Section 42020. Governmental Depository. The Nieves M. Flores  
6 Memorial Library is designated the depository for all government  
7 publications including any printed or processed paper, book,  
8 periodical, pamphlet or map, originating in, or printed with the  
9 imprint of, or at the expense and by the authority of the government  
10 of Guam."

11 Section 3. The sum of Forty-Five Thousand Dollars (\$45,000) is  
12 appropriated from the General Fund to the Public Utility Agency of Guam  
13 for the purpose of extending the sewer line from Route 10, Tai, Mangilao to  
14 the neighborhood of the Infant of Prague Nursery, and Mercy Convent to  
15 service the twenty (20) families living in the area.

1 Section 4. Subsection (b) of Section 11102 of the Government Code is  
2 hereby amended to read as follows:

3 "(b) The Student member shall be a public school freshman,  
4 sophomore or junior at the time of his selection and shall serve for a  
5 term of one (1) year beginning at 12 o'clock noon on June first of the  
6 year in which he is selected. The Student member shall be selected  
7 by a plurality vote of freshmen, sophomores, juniors, and seniors  
8 attending public schools, voting in an election held in all the public  
9 high schools on one day in May of each year. This selection shall be  
10 supervised by the Director in cooperation with student governing  
11 bodies. Any student member candidate must be nominated by a  
12 petition signed by one hundred (100) freshmen, sophomores, juniors,  
13 and seniors from the public schools. No student may be a candidate if  
14 he is under suspension or on academic probation at the time of his  
15 nomination. Any vacancy during the term of a student member shall  
16 be filled for the remainder of the term by appointment by the Guam  
17 Youth Congress."
