CERTIFICATION OF PASSAGE OF AN ACT TO THE GOVERNOR

This is to certify that Substitute Bill No. 688, "AN ACT RELATIVE TO CURBSIDE PARKING IN ROADWAYS ADJACENT TO PLACES WHERE RELIGIOUS SERVICES OCCUR," returned to the Legislature without the approval of the Governor was, in accordance with the Organic Act of Guam, reconsidered by the Legislature and after such reconsideration, the Legislature did, on the 1st day of August, 1984, agree to pass said bill notwithstanding the objections of the Governor by a vote of two-thirds of all members thereof, to wit: by a vote of 19 members.

AN ACT RELATIVE TO CURBSIDE PARKING IN
ROADWAYS ADJACENT TO PLACES WHERE RELIGIOUS
SERVICES OCCUR.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:
2 Section 1. A new Section 23132.4 is added to the Government Code to
3 read:

4 "Section 23132.4. Parking for Religious Services. No provision
5 of this Code shall be enforced to prevent a person attending a place
6 wherein a religious service is conducted from parking curbside upon a
7 roadway within reasonable proximity of the place during the service."

8 Section 2. On Chalan San Antonio in Tamuning beginning at Espirito
9 Street and ending at San Vitores Road, the curbside lane on each side of
10 the roadway shall be designated for parking only.
