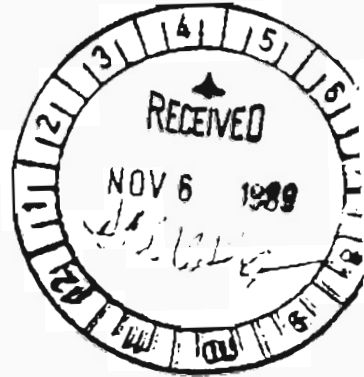





1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. (a) Twelve Thousand Four Hundred Sixty-Five Dollars  
 3 and Eighty-Four Cents (\$12,465.84) are hereby appropriated from the  
 4 General Fund to the Guam Power Authority to install power poles and power  
 5 lines at Lupog, Yigo (Service Order No. 11454).

6 (b) Four Thousand Six Hundred Seven Dollars and Eighty-Eight  
 7 Cents (\$4,607.88) are hereby appropriated from the General Fund to the  
 8 Guam Power Authority to extend a power line at Tai, Chalan Pago (Service  
 9 Order No. 30756).

1           Section 2. Twenty-Five Thousand Dollars (\$25,000) are hereby  
2 appropriated from the General Fund to the Department of Labor to fund a  
3 contract whereby the Department of Labor can be represented in the  
4 Republic of the Philippines.

5           Section 3. Section 1 of Public Law 20-48 is hereby amended by adding  
6 the following sentence thereto:

7                   "Of the foregoing appropriation, Eighty-Seven Thousand Seven  
8           Hundred Two Dollars (\$87,702) shall be utilized to recruit three (3)  
9           additional full-time equivalent employees as Medicaid Specialists."

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

2 Section 1. (a) Twelve Thousand Four Hundred Sixty-  
3 Five Dollars and Eighty-Four Cents (\$12,465.84) are hereby  
4 appropriated from the General Fund to the Guam Power Authority  
5 to install power poles and lines at Lupog, Yigo (Service Order No.  
6 11454).

7 (b) Four Thousand Six Hundred Seven Dollars and  
8 Eighty-Eight Cents (\$4,607.88) are hereby appropriated from the  
9 General Fund to the Guam Power Authority to extend a power line at  
10 Tai, Chalan Pago (Service Order No. 30756).

11 Section 2. Twenty-Five Thousand Dollars (\$25,000) are  
12 hereby appropriated from the General Fund to the Department of  
13 Labor to fund a contract whereby the Department of Labor can be  
14 represented in the Republic of the Philippines.

15 Section 3. Section 1 of Public Law 20-48 is hereby  
16 amended by adding the following sentence thereto:

1                   "Of the foregoing appropriation, the sum of Eighty-Seven  
2            Thousand Seven Hundred Two Dollars (\$87,702) shall be utilized  
3            to recruit three (3) additional full-time equivalent employees as  
4            Medicaid Specialists."
