Transmitted herewith is Substitute Bill 630 which has been signed into law as Public Law 20-129.

Unfortunately, Mr. Cruz has passed away. The Department of Land Management will shortly advise you the name of the next eligible applicant.

With respect to Item 3., the area of Lot No. 23, Block No. 4 is 1373.14 square meters. The Attorney General has advised that exact descriptions are necessary in order to establish authority for conveyance of the lots.

I am confident that these remaining discrepancies will soon be corrected so that the conveyances may be made,



Mr. Cruz stated that this amendment is necessary to correct the discrepancies on Public Law 19-52.

FINDINGS/RECOMMENDATIONS

Bill 630 is necessary to clarify and fulfill the intent of Section 4, Public Law 19-52. Some of the land area noted in the law do not correspond with the Department of Land Management's approved map.

The Committee recommends Bill No. 630 be passed by the Twentieth Guam Legislature.

Section 5. The Director of Land Management and the Attorney General shall take all necessary action to effectuate the land sales authorized by Section 4 of this Act. The Governor of Guam shall execute all documents and instruments necessary to carry out the provisions of Section 4. The provisions of Section 3 of P.L. 12-61, as amended, shall not apply to the land sales authorized by Section 4.

Section 6. Notwithstanding any other provision of law, rule or regulation to the contrary, the sales authorized in Section 4 are approved by the Legislature.

Section 7. Section 6208.1 of Chapter 6, Title 4, Guam Code Annotated, is repealed and reenacted to read:

"Section 6208.1. Recruitment of Assistant Attorneys General. Notwithstanding any other provision of law, the Attorney General may hire Assistant Attorneys General necessary for the operation of the department. Attorneys shall be hired for an initial two-year probationary period in the unclassified service, which shall by the term of the appointment expire two years from the date of the appointment if not sooner terminated by the appointing authority. Attorneys reappointed after completion of their probationary period shall be employed in the unclassified service as provided under Section 4102(16) of Chapter 4 of this Title and may be removed only for
