(2) The option not to originate long distance calls at the subscriber's telephone or an option which would require the subscriber to give a credit card number for each long distance phone call made.

(e) Access to long distance telephone service may be terminated as a result of unpaid and overdue long distance charges owed by a subscriber and charged to the subscriber's telephone on Guam. In such cases, notice of such termination of access to long distance services shall be given by the Guam Telephone Authority to the subscriber, which notice shall include the date, time, number of origin, place of origin, length of call, and charge for each such phone call, and, in addition, shall include the name of the person receiving the call and the name of the caller, if known, to the long distance carrier. Such notice shall be mailed to the subscriber by registered or certified mail return receipt requested at the subscriber's last known address. Long distance access may be denied only to the telephone upon which the calls were made or to which the calls were charged. Local service may be terminated only for unpaid collect calls charged to the numbers in question.

(f) No service (local or long distance) may be terminated because of an unpaid bill for charges on some other telephone line even if the subscriber in question has more than one line, nor for any charges incurred on any charge account number or credit card.

(g) If any part of this section shall be found to be invalid because it is contrary to the Organic Act of Guam or the Constitution or laws of the United States, all other provisions of this section which are not invalid shall remain in effect."

AN ACT TO CONSTRUE CERTAIN PORTIONS OF THE GENERAL APPROPRIATIONS ACT FOR FISCAL YEARS 1990 AND 1991 ON HAZARDOUS PAY FOR MARSHALLS, PROBATION OFFICERS, AND ALTERNATIVE SENTENCING OFFICERS OF THE SUPERIOR COURT OF GUAM AND FOR POLICE OFFICERS OF THE GUAM POLICE DEPARTMENT, TO AMEND §6222 OF TITLE 4, GUAM CODE ANNOTATED, AND TO ADD §§6223 AND 6224 TO SAID TITLE, TO SO PROVIDE, AND TO AMEND §4102 OF SAID TITLE TO MAKE A POSITION AT THE DEPARTMENT OF CORRECTIONS UNCLASSIFIED.

BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

Section 1. The appropriations made in Subpart D of Part XLIV of Chapter II of Public Law 20-41, as amended in Subsections (f) and (g) of Section 18 of Public Law 20-94, and in Subpart E of Part XLIV of Chapter II of Public Law 20-41, as amended in this Act, include payments for hazardous pay pursuant to §6222 of Title 4, Guam Code Annotated.

Section 2. §6222 of Title 4, Guam Code Annotated, is amended by entitling its current provisions subsection (a), and by adding a new subsection (b) to read:

"(b) Any marshal, probation officer, or alternative sentencing officer of the Superior Court of Guam is eligible to receive hazardous pay for any duty considered to be under hazardous conditions as specified by the Superior Court of Guam's Personnel Rules and Regulations."

Section 3. (a) Subpart E, 1 of Part XLIV (Superior Court of Guam) of Section 1 of Chapter II of the General Appropriations Act for Fiscal Years 1990 and 1991 (the "Act") is amended to read:

Section 4. The provisions of Sections 1, 2 and 3 of this Act shall be effective October 1, 1989.

Section 5. §6223 is hereby added to Title 4, Guam Code Annotated, to read:

"§6223. Police Officers -- Hazardous Pay. A police officer assigned to a hazardous duty position is entitled to hazardous duty pay calculated at the rate of such officer's wage plus ten percent (10%)."

Section 6. §6224 is hereby added to Title 4, Guam Code Annotated, to read:

"§6224. Hazardous Duty Positions Identified. The Chief of Police shall, by general order, adopt a Table of Organization and Equipment ("TOE") for the uniform positions within the Police Department. The TOE shall follow generally the organizational structure established by the reorganization plan for the Police Department which became effective September 11, 1989. The TOE shall identify by rank and duty the positions within the various units, sections, branches, divisions and commands in the Police Department. Hazardous duty positions shall be identified in the TOE."

Section 7. (a) Subpart C, 1 of Part XLI (Guam Police Department) of Section 1 of Chapter II of the Act is amended to read:

Section 8. The provisions of Sections 5, 6 and 7 of this Act shall become effective 120 days after its enactment. The Chief of Police shall transmit to the Legislative Secretary the general order described in Section 6 of this Act no later than April 1, 1990.

"(16) Property Management Officer at the Department of Corrections."
