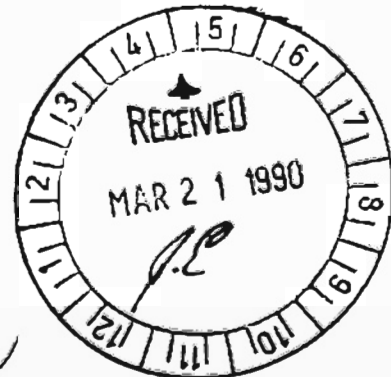





2 Section 1. Legislative finding. The government of Guam is in the

8 Section 2. One Million Dollars (\$1,000,000) are appropriated from the
9 General Fund to the Guam Community College to revise its master plan for a
10 new campus, to survey the land obtained for such new campus, and to

1 prepare its site. Such appropriation is hereby taken from Section 2 of
2 Public Law 20-39, which Section 2 is hereby reduced by such sum.

PREFACE

The Committee on Education conducted a scheduled public hearing on Thursday, February 15, 1990, in the Legislative Session Hall. Committee members present at the hearing were as follows:

BACKGROUND

Testimonies heard on Bill No. 1165 were as follows:

1. Mr. John T. Cruz, President, Guam Community College

Mr. John Cruz, President of the Guam Community College presented a written testimony on behalf of Guam Community College. Mr. Cruz testified that the Guam Community College has land that has been identified for the new campus and a five-year master plan which will enable them to reach their potential as a premier educational institution in the pacific.

Mr. Cruz goes on to mention that they are lacking the funds to revise their facilities master plan in conjunction with the new site, surveying and site preparation costs. Mr. Cruz stated that he appreciated the support given to the college regarding this bill and urges expediency on this matter.

2. Dr. John Salas, Chairman, Board of Trustees, Guam Community College

Dr. Salas provided an oral testimony. He stated that he strongly supports the bills intent and recommends that the bill be passed.

Discussions following the above testimonies were as follows:

a. Senator Quitugua thanked Mr. Cruz and Dr. Salas for submitting their testimonies regarding Guam Community College. The Senator also suggested to meet again soon with Guam Community College and discuss future assistance.

ANALYSIS OF BILL NO. 1165

Bill No. 1165 seeks to make public law that one million dollars (\$1,000,000) be appropriated from the general fund to the Guam Community College for the purpose of revising its master plan for a new campus, surveying costs for the land obtained for the new campus and site preparation costs for the new campus.
