- 2 December 23, 1991 by the board of directors of the Guam Visitors Bureau
- 3 ("GVB"). Previous appropriations totaled One Million Six Hundred
- 4 Thousand Dollars (\$1,600,000) although the total preliminary estimated cost
- 5 amounted to Two Million Five Hundred Thousand Dollars (\$2,500,000). It is
- 6 the intent of the Legislature to expedite the finding and construction of the
- 7 GVB office building which has been on the drawing board for the last four
- 8 years.
- 9 Section 2. Appropriation. Nine Hundred Thousand Dollars (\$900,000)
- 10 are hereby appropriated from the Tourist Attraction Fund to GVB for the
- 11 purpose set out in Section 1 of this Act.

BILL 757 AN ACT TO APPROPRIATE NINE HUNDRED THOUSAND DOLLARS (\$900,000) FROM THE TOURIST ATTRACTION FUND TO THE GUAM VISITORS BUREAU TO FUND THE DESIGN AND CONSTRUCTION OF THE OFFICE BUILDING.

Present at the hearing were Senators John Perez Aguon,
Chairman of the Committee, Pilar C. Lujan, David L. G. Shimizu, J.
George Bamba, Frank Santos and Michael Reidy.

Signing in to present testimony in favor of the bill were Architects Jack B. Jones, Liza Provido and Steve Lander, Peter Sonny Ada, GVB Board Chairman, Joey Cepeda, GVB General Manager, Bruce Kloppenburg, GVB Board member, and John Salas, Exec. Dir. of the Guam Hotel & Restaurant Association.

Senator Aguon, before hearing testimonies, expressed concern that there was no representation from the TAF Committee which made the recommendation to the Board for the additional funding needed to construct the GVB office building and reminded the General Manager that he would like to see GVB committee members participate in hearings on issues which they recommended and approved by the Board so that the Committee on Tourism and Transportation can hear from them directly. He said he hopes that in the future committee members responsible for certain issues

concerning GVB, such as during budget hearings, will make themselve available for discussion.

In his written testimony, Board Chairman Ada "walked" the committee members through the chronology of the GVB office building development. He pointed out that Public Law 19-27 enacted in 1988 appropriated \$600,000 to construct the GVB building at a proposed site near the Matapang Beach Park in Tumon but subsequently the site was not made available for the purpose.

In 1990, Public Law 20-221 authorized the Governor to transfer and convey the ponding basin site fronting the Ypao Beach Park to GVB for the purpose of constructing and office building and appropriated an additional \$1,000,000 for construction and furnishings. In October 1991, a notice to proceed was issued to GVB's architect J. B. Jones and the proposed design schemes were subsequently to GVB for selection.

Ada wrote: "Considering that the selected design scheme factored in all necessary requirements for the selected site and features modest amenities; addressed the prevailing construction costs; provides for flexibility for future considerations, i. e. increased staffing and accompanying space requirements, and does include material finishings, such as floor, tile, carpet, roof tile, painted gypsum wallboards and flourescent light fixtures, etc.; this should be the final request from the Bureau for additional project funds. The total cost estimate with the changes is estimated at \$2.5 million."

In his written testimony, John Salas wrote, among the reasons the GHRA supports Bill 757, that the "...The combined effect of first-

class promotional materials and visitor industry facilities on our island that GVB's office appearance be consistent with that environment. This will most certainly cost money and, while conceptual designs should not be pretentious, the physical appearance of our island's promotional agent should also first rate." Salas further said: "The impact of Bill 757's expenditure of Tourist Attraction Funds will be a positive benefit for tourism operators on a long term basis."

Before architect Jack B. Jones begins his presentation to the committee of the final conceptual plans for the building and the final cost estimate for the plan approved by the GVB Board, Senator D. L. G. Shimizu first asked what was the total appropriation to date, since the Board chairman mentioned an additional one million dollars appropriation, was there money before the additional one million?

Committee Chairman, Senator Aguon, informed Senator Shimizu that, as testified by the GVB Board Chairman, there was a \$600,000 appropriation since 1988 by the 19th Guam Legislature and \$1,000,000 appropriated in 1990 by the 20th Guam Legislature and Bill 757 is now requesting additional appropriation of \$900,000 for a total estimated amount of 2.5 Million Dollars, from previous appropriation to date.

Senator Shimizu wants to know if GVB instructed its architect in 1990 to build the facility for !.6 Million Dollars already appropriated at that time.

Chairman Aguon again responded: "No, the testimony, as it reads, they were never in the position to do anything because they

don't have a site. They can't draw their building, they can't have their $\lambda \in E$ because the government has not decided as to where they λ and be situated."

Senator Aguon then asked the committee members to allow the architect to proceed with the presentation and to make sure that they have their list of questions ready after the presentation.

Jones began his presentation giving the members an orientation of the ponding basin in Tumon where the GVB building is to be located. He then proceeded to describe and explain the conceptual plan for the type of building that can be built over the ponding basin with the 1.6 Million Dollar already appropriated and still keeping the use of the basin as efficient as possible by putting in an infiltration system. Jones said that during this part of the design they have coordinated with the Department of Public Works and GEPA to sound them out as far as the drainage system itself.

In response to Senator Frank Santos' concern whether the construction of the GVB building over the ponding basin will aggravate the drainage problem along San Vitores Road, Jones said that they have taken all that into consideration in their approach and assures the Senator that the basin will still serve as a ponding basin.

Senator Santos wanted to know how long will it take to complete construction following ground breaking. Jones said that it will take anywhere from one year to eighteen months.

Senator George Bamba wanted to know if the cost of the infiltration system is included in the 2.5 Million Dollar estimate. Jones responded in the positive. Senator Bamba further ask if the

building will infringe on the park area or planned expansion of the park. Said that he doesn't believe so because they have been coordinating with the Department of Parks and Recreation and vise versa.

Senator Shimizu asked GVB where do they think the business of the Bureau should be located of all the sites on the entire island given GVB's needs and the needs of the people of Guam?

Joey Cepeda told the Senator that it's down in the Tumon area, the heart of the visitor industry.

Senator Shimizu asked if there was any public input on the proposed location of the GVB building and Cepeda answered negative.

Senator Shimizu said that he sees the need and agrees that GVB should have a permanent place to showcase and enhance tourism on Guam but he also in principle look at the limited land resources in Tumon for the people of Guam to be able to recreate themselves.

At this point, Chairman Aguon interjected and told Senator Shimizu that if there's any blame to be made on the site, he will take the blame because he made that decision and anyone can introduce legislation to change the site if he so desires.

Right now it is by law, authorized by the Legislature that that building should be located on that particular site", Senator Aguon said. "I am not going to allow any debate for other locations because the law is specific already, it shall be located right there", Senator Aguon said.

Secator Shimizu said that he just wants to see how much public. It was put in that decision and he just wants to expressed his thoughts in the limited area for acreage for the recreation activities for the people. He insisted on asking the GVB General Manager what other location would he suggest if there is going be an introduction of legislation of other locations but Senator Aguon told him that the law is very specific and he will stop the discussion if Senator Shimizu were to ask questions other than the site that is being discussed in the bill.

"The public hearing is for an appropriation for a building on a particular site", Senator Aguon told Senator Shimizu.

The architect, Jack Jones who said he had been through other sites, offered to point out the advantages of the ponding basin site for the GVB building and Senator Aguon told him to proceed with any information for the record.

Jones noted the extent of the perimeter encompassing the ponding basin area and told Senator Shimizu that they are not taking away any recreational area from anybody because the basin is a very confined site that is a hole in the ground. He said: "Quite frankly, whether it's my building or somebody else's, if its handled in a tasteful manner with earth tone materials, it will look better there from the tourist standpoint and from the view standpoint, it will look much better there than that hole in the ground".

Senator Shimizu thanked Jones for pointing out the advantages of the ponding basin and said that he is looking at the site in terms of the neighbors, the recreational aspects of Ypao. He said that if he is ruled out of order in his line of questioning as to

how the ponding basin site and the recreational aspects of Ypao blend and compliment one another, he apologized to the Chairman but he and to look at that and raise those issues.

Referring to the Chairman, Senator Shimizu said: "I know you put a lot of work on this, I have seen the efforts of your work in the past and I do have an historical perspective on this area. But I think it also would behoove me not to take into consideration the dwindling acreage in that area and to raise that because the architect is still developing at the conceptual level. Concept, have you taken the total area keeping in mind the recreational nature of the area and if conceptually it can blend into the area, I may not have that much objection".

Senator Shimizu asked the architect what is the additional cost of building over the ponding basis versus that of a flat ground? Jones responded that the cost of building over the ponding basin is significant because of the infiltration system. The Senator also wanted to know if the infiltration system is large enough to hold all the water given the amount of rainfall and nonpoint pollution coming through that area and Jones answered positive.

Senator Shimizu said that he doesn't want the most prestine natural park of Tumon to be overflowed and flooded because of the structure. He said that he wants to be assured that the infiltration system will adequately hold the water coming through at the rate of the rainfall.

He said that it would be prudent for him to raise those issues about the site that is already selected by law but he is will aware that it is still in the conceptual stage and laws can be amended too. He

,

said he needs to raise those issues because of his two concerns. How does received in with the neighboring acreage of government property and the home owners, I am not aware if there are any input. He said he will continue to raise the issues if he can see that the GVB building will enhance the neighboring recreational needs of Ypao Park.

Addressing the architect, Senator Aguon and Joey Cepeda, Senator Shimizu said: "You know my concerns, I am not against your need for the building but I want to see how far have we looked at it, or are we saying, 'this is all I want to look at, I am not going to entertain any other location' and I wanted to raise and ask that question?"

Senator Aguon retorted: "That's not what I was inferring to Senator about looking at other location. You have to start at a given point and I will like to encourage, because I don't want to see any short cuts here, we are starting a process. The agencies that are entrusted with the responsibilities on any development will have to be consulted. They have to go through the process, they have to check with PUAG for the drainage system, check with the environmentalists, check with all the agencies, they have to start somewhere and this is the beginning point. I don't want anybody to go through this process using short cuts. If there is any problem during the process, of course the decision will be made to change the location. But right now, let's look at the process, look at the concept and if the concept is agreeable, let's work it through and clear it with all the agencies that are entrusted with the responsibilities in reviewing any development in this territory, and

this is not going to be an exception. That's the normal process in any development and I don't want to see any short cuts. So any impact assessment will be made during the process, but they have to start somewhere. If it's not feasible, I'm not going to sit back and just watch this thing go, we'll change the place. But that's the way a development application is done in this territory and I encourage the leadership of GVB and I will oversee it to make certain that this in fact is feasible".

Senator Michael Reidy said that he also supported Senator Aguon and his chairmanship of the committee but he does have an issue with the project. He said that what he sees is a structure which is primarily an office building and asked about what percentage of the area will be used for visitor reception and promotions?

Jones responded that there is a two-part answer to the question. He said that if the visitor goes in through the visitor information section, that's about 10% and if he goes in through the lobby to get the view, that's about 7%.

Senator Reidy also wanted to know if the drainage system is similar to the drainage system underneath the Matapang Park where a number of pipes are put out beneath the surface and the water runs through and let out for perculation. Jones said that conceptually they are similar, although they are different in scale and different materials.

Senator Reidy said that the drainage system as proposed could be put in the ponding basin and not put a building on top and other uses could be made of that property. He said that all he is trying to suggest is that Ypao Beach is the major park serving the community,

it's intensively used and every weekend it's becoming busier and I for one aink that as the population grows park resources should be maintained for park purposes.

Senator Reidy recommend to the chairman that other hearings be held maybe down at Ypao Beach to find out generally what the public might want.

Bruce Kloppenburg, GVB Board member, said: "I a little bit surprised at the direction that the hearing has taken, frankly we weren't prepared to discuss the location of the site because the site has been deeded to GVB through public law signed by the governor, and the Board of Directors has taken that direction. We're here to ask you for an additional \$900,000 to build the structure on this site, we're not here to debate the site. We are prepared to discuss the \$900,000 that we're asking for, it's not a presumptuous building, it is a visitors site that allows us for expansion in the years to come. I am prepared to justify asking for the \$900,000. But our hand are tied at the Bureau because that is public law that the property has been deeded to the Bureau to build their building on and the design that Mr. Jones has come up with will enhance that particular site".

Addressing Senator Reidy, Bruce said: "I know the issues you are talking about but are these issues relevant now that the property has been deeded to us" Senator Reidy interjected: "I'll be asked, if the chairman reported out this bill on the floor to appropriate \$900,000 towards this project I have to vote on it, I wasn't a Senator in the 20th Guam Legislature. I came here because my initial reaction was not to build a structure in Ypao Beach for use as

primarily an office but I wanted to come and listen to the design present. A cause I owe it to the chairman and to my colleagues and I am not shooting from the hip, so I want to know a little bit more about the project. I think it's appropriate for me to raise some of these issues because I think the public is going to."

Senator Shimizu repeated his concerns in Bill 757 and said that he is at the hearing to try to listen and raise questions in terms of the \$900,000. He said: "Am I to vote on the \$900,000 only on financial issues and not raise those other issues and it is to be called a debate or my colleague being critical, then I should necessarily have to be here if its just a money issue.

"I can talk about that \$900,000 in concrete terms but that doesn't necessarily will help me to make a better decision. I will not vote on an additional \$900,000 because I have been limited to discuss only that impact. If I am going to stay here as a duly elected Senator to only discuss close to a million dollars to get this building going, then I think I'll say 'no', I think 1.6 is enough, build at 1.6 or my vote will be no. But I'm trying to look in terms of the other issues.

My intent is to look at that additional \$900,000, if it does not go in line with some of my own thoughts and thinking in that area, then I will vote 'no'".

There being no further witnesses, the hearing was declared adjourned.

MARK-UP MEETING

The Committee on Tourism and Transportation held a markup meeting in the Legislative Public Hearing Room at the Pacific Arcade building on Tuesday, March 3, 1992 at 9 a. m. to discuss Bill 757.

RECOMMENDATIONS

The Committee recommended to amend Section 1 of the bill to reflect the urgency of the GVB building and to pass Bill 757 as amended.

COMMENTS NO. 757

On October 24, 1988, Public Law 19-27 was enacted into law which appropriated the sum of \$600,000 from the Tourist Attraction Fund (TAF) to the Guam Visitors Bureau (GVB) for the construction of a new office building. Public Law 20-221 enacted into law on December 31, 1990, appropriated the sum of \$1,000,000 from the TAF to GVB to construct and furnish an office building on a designated lot in the Tumon area.

Bill No. 757 proposes to appropriate an additional \$900,000 from the TAF to supplement the \$1.6 million already appropriated for the construction project. This will bring the total amount appropriated for the project to \$2.5 million.

Information received from Joey Cepeda, General Manager, GVB revealed that the present construction cost estimates for the proposed GVB office building is \$2.5 million. The Bureau is concerned that due to the length of time which has elapsed to initiate the project, the present cost estimate may be inadequate once actual construction of the project begins.



Dear Mr. Chairman:

On behalf of the Board of Directors, Management and Staff of the Bureau, thank you for providing us an opportunity to comment on Bill 757: AN ACT TO APPROPRIATE NINE HUNDRED THOUSAND DOLLARS (\$900,000.) FROM THE TOURIST ATTRACTION FUND TO THE GUAM VISITORS BUREAU TO FUND THE DESIGN AND CONSTRUCTION OF THE OFFICE BUILDING.

In 1988, Public Law 19-27 appropriated six hundred thousand (\$600,000.) to GVB to construct an office building. The proposed site at the time was near the Matapang Beach Park. This site was subsequently not made available for that purpose. Other sites identified and recommended included Hospital Point overlooking the Guam Hilton Hotel, near the rotary intersection of Chalan San Antonio and Chalan San Vitores; and the ponding basin fronting Ypao Beach Park. Architect/Engineering services had also been selected several years ago, however, work had been delayed because no site had yet been confirmed.

In 1990, Public Law 20-221 authorized Governor Joseph F. Ada to transfer and convey the ponding basin site to GVB for the purpose of constructing an office building and appropriated an additional one million (\$1,000,000.) for construction and furnishings. The ponding basin site was deeded to GVB in the first quarter of 1991 allowing the Bureau to initiate the necessary paper work for property title; hence, by October 1991, a notice to proceed was issued to GVB's architect J.B. Jones. The proposed design schemes were subsequently submitted to GVB for selection.

Considering that the selected design scheme factors in all necessary requirements for the selected site and features modest amenities; addresses the prevailing construction costs; provides for flexibility for future considerations (i.e. increased staffing and accompanying space requirements) and does include material finishings (such as floor tile, carpet, roof tile, painted gypsum wallboards and flourescent light fixtures, etc.); this should be the final request from the Bureau for additional project funds. The total cost estimate with the changes is estimated at \$2.5 million.


