AN ACT TO REPEAL AND REENACT PARAGRAPH (b) OF SECTION 10, PUBLIC LAW 22-20, RESPECTING A LAND EXCHANGE IN IJA, INARAJAN.

1 BE IT ENACTED BY THE PEOPLE OF THE TERRITORY OF GUAM:

**Section 1.** Paragraph (b) of Section 10, Public Law 22-20, is hereby repealed and reenacted to read:

"(b) Land exchange authorized. The Governor is authorized to exchange with the owners of Lot No. 56-R8, Ija, Inarajan (the "Owners"), government of Guam land on a value-for-value basis for whatever parcel of land within the basic Lot No. 56-R8 is agreed shall provide a public access and utility rights-of-way easement fifty feet (50') in width leading to the government of Guam subdivision located on Tract No. 3734, Inarajan. Determining the location and size of the easement and the government of Guam land to be exchanged therefor shall be as agreed between the Director of Land Management and the Owners. The Legislature hereby approves in advance such selection of the site of the easement and the resulting land exchange, and no subsequent approval of the Legislature is required."

#### . I. OVERVIEW

The Committee on Housing and Community Development scheduled a public hearing on April 18, 1994 at 9:00 a.m. at the Legislative Public Hearing Room. Public notice was printed in the Pacific Daily News on April 16, 1994. Members present were:

Senator Edward Reyes, Chairman Senator Ted Nelson, Vice-Chairman Senator Tom Ada Senator Elizabeth Arriola Senator Marilyn Manibusan Senator Ben Pangelinan.

Appearing before the Committee to testify on the bill were:

Peter San Nicolas, owner of Lot 56-11R/W, Inarajan Jesse Perez, Inarajan Mayor Joseph M. Borja, Chamorro Land Trust Commission Administrative Director Ben Meno, private citizen.

#### . II. SUMMARY OF TESTIMONY

Mr. San Nicolas testified that he is willing to exchange a portion of his property to allow public access and utility easement for the Ija, Inarajan government lot reserved for the land-for-the-landless program. Mayor Perez testified that many families have inquired about this exchange because it affects implementation of said program. Ben Meno testified that the exchange would be beneficial for the 300 families wating on the program.

Mr. Borja testified that the Commission supports the measure because it facilitates access to the land-for-the-landless area as well as access to Commission land in the vicinity. He is supporting the bill, provided that whatever portion of Lot No. 10120-R16 is given to Mr. San Nicolas is surveyed out of the 70 acres reserved for such exchanges and provided that the Commission is also given access at Ija.

#### · III. FINDING AND RECOMMENDATION

The Committee finds that Public Law 22-20 was the original authorization to exchange 6,000 square meters of government land for a portion of San Nicolas property marked as Lot No. 56-9R/W. This bill identifies a different area to avoid the problem pointed out by the Department of Land Management which would cost more in excavation costs and elimination of two lots for the land-for-the-landless program.

The Chamorro Land Trust Commission and the Inarajan Mayor favor this bill because it would facilitate land uses for both Commission and land-for-the-landless.

Accordingly, the Committee on Housing and Community Development, to which was referred Bill No. 798, does hereby submit its findings and recommendation to the Twenty-Second Guam Legislature "TO DO PASS" Bill No. 798, as amended by the Committee - "An Act to Amend Paragraph (b) of Section 10, Public Law 22-20, to Change the Lot Number and Method of Exchange for a Land Exchange in Ija, Inarajan".






