Dear Mr. Speaker:

Enclosed is Substitute Bill No. 556 which I have signed into law as Public Law 22-41 with certain reductions and exceptions.

The Mayors of Agana Heights and Tamuning have sufficient personnel to operate the gymnasiums located in their villages. In Section 24 I have reduced the appropriations for maintenance of the gymnasiums to \$25,000 each. The \$25,000 is enough to hire additional part-time maintenance personnel, if needed, and purchase cleaning supplies. The \$180,000 saved is better spent constructing gymnasiums in other villages.

The Executive Director of the Guam Election Commission has informed me that the appropriation made in Subsection (b) of Section 33 is not needed so I have item vetoed it.

I have item vetoed all appropriations for private residential utility connections contained in Sections 34 (ii), 59 and 63. To begin paying all connection expenses sets an extremely dangerous and expensive precedent. If the government assumes this financial obligation it will drain government resources unnecessarily now and in the future. The over \$1,000,000 appropriated in this measure is insufficient for even fiscal year 1994. For example, in fiscal year 1993 approximately \$1,500,000 was paid by customers to Guam Power Authority for residential line extensions and connections. The money should be spent to make improvements in the islandwide water and sewer system which benefit all of us.

The government cannot do more than it is doing now. operations and capital improvement projects are already heavily subsidized from the General Fund. Just in fiscal year 1994 alone approximately thirty five million dollars will be expended for the islandwide water and sewer system. Similarly we have expended funds for the benefit of the islandwide power system through the purchase of the Dededo generator and emergency generators.

Thousands of residential customers have paid for



connections over the past years. It is fundamentally unfair to them to start paying now for future residential customers. Will be faced with lawsuits to end a discriminatory process? It is far wiser to direct government resources to system wide improvements not to the benefit of a select group.

Previously I have advised the Legislature that it is impractical to pay transportation expenses and per diem for patients and escorts for off-island medical treatment. Patients who are hospitalized do not require per diem since their hospital expenses are paid by insurance companies or government programs. If we provide per diem to off-island patients must we also provide it to on-island patients?

At this time two medical referral offices are operating, one in Hawaii and one in Los Angeles. Since November 1989 the Hawaii office has served 1,756 patients and since April 1992 the Los Angeles office has served 279 patients. If these patients (who do not include all off-island referrals) received only economy round trip transportation then the government would have spent \$2,000,000. If each of the patients stayed ten days for treatment then they would have received \$1,500,000² in per diem. (Many patients have longer stays.) This amount does not include travel or per diem for the patient and escort authorized in the law. If you assume half of the patients have escorts then another \$1,750,000 would be required. Next if you double the number of patients to approximate total off-island referrals then the estimate is roughly \$10,500,000 since November 1989 or \$2,200,000 per year.

I have item vetoed the appropriation made in Section 60 because the annual cost of such a program for fiscal year 1994 alone could easily exceed \$2,000,000. There is certainly not enough money for the retroactive payments contemplated in this Section. The money not spent for individual patients is better earmarked to improve our on-island health care system.


