The Fire Chief shall meet the following qualifications: 13 (1) Must have a bachelor's degree in Fire Science or 14 (a) Public Administration or closely related field or 15 16 discipline at an accredited institution; and 17 (2) Have at least ten years of experience in fire control 18 including control and extinguishment of fires and fire 19 prevention, of which two years must be served in a 20 position equivalent to Battalion Chief or higher; or 21 (b) (1) Must have an associate's degree in Fire Science or 22 closely related field or discipline at an accredited 23 institution; and (2) Have at least 15 years experience in fire control, 24 25 including control and extinguishment of fires and fire 26 prevention, of which four years must be served in a

position equivalent to Battalion Chief or higher.

JUNE 30, 1995

I. OVERVIEW

The Committee on Judiciary, Criminal Justice and Environmental Affairs scheduled a public hearing on June 30, 1995 at 1:30 p.m. at the Legislative Public Hearing Room. Public notice was announced on the June 28, 1995 issue of the PDN. Members present were:

Senator Mark C. Charfauros, Chairman Senator Elizabeth Barrett-Anderson

Appearing before the Committee to testify on the bill was:

Mr. Gil Reyes, Acting Chief, Guam Fire Department, oral, written.

Mr. Thomas Tedtaotao, Captain, Guam Fire Department, oral.

II. SUMMAR OF TESTIMONY


Mr. Gil Reyes, Acting Chief, Guam Fire Department, testified in support of Bill 270. He stated that it is necessary to amend the current law regarding the qualifications of the Fire Chief because there are no known individuals on Guam who meet the current requirements; written; attached.

Mr. Thomas Tedtaotao, Captain, Guam Fire Department, testified against Bill 270 as currently written. He stated that subsections c and d should be eliminated, stating that the Chief should be required to have a bachelor's degree. He further stated that the education requirements of the Fire Chief should not be decreased because such a position involves specific administrative and management skills. In responding to such concerns, the author and Chairman of the Committee stated that limiting the position to individuals with a bachelor's degree would seriously restrict the pool of qualified candidates, especially within the Department. Mr. Tedtaotao maintained his position that the Chief should have a bachelor's degree.

III. FINDING AD RECOMMENDATION

The Committee finds that Bill 270 is essential because of the unrealistic requirements of the current law. Under the current statute, candidates for the position of Fire Chief must possess a bachelor's degree in Fire Science, a degree that places an unreasonable burden on the candidate because it is only offered by a few institutions. The Committee finds that bill 270 effectively modifies the educational qualifications while simultaneously adjusting specific experience requirements in order to generate a realistic pool of candidates upon which the appointor may draw. The Committee further finds that the adjustment of such requirements will not result in any depreciation of the quality of candidates for the position of Fire Chief.

Accordingly, the Committee on Judiciary, Criminal Justice and Environmental Affairs, to which was referred **Bill No. 270**, does hereby submit its findings and recommendation to the Twenty-Third Guam Legislature **TO DO PASS Bill No. 270**, **As substituted by the author** "AN ACT TO AMEND SECTION 3105, OF TITLE 5 GUAM CODE ANNOTATED, RELATIVE TO THE QUALIFICATIONS OF THE FIRE CHIEF."

TESTIMONY

BILL NO. 270

AN ACT TO AMEND SECTION 3105, OF TITLE 5 GUAM CODE ANNOTATED, RELATIVE TO THE QUALIFICATIONS OF THE FIRE CHIEF.

Good afternoon Mr. Chairman and members of the Committee on Judiciary, Criminal Justice and Environmental Affairs, Twenty-Third Guam Legislature. My name is Gil P. Reyes and I am presently the Acting Fire Chief for the Guam Fire Department.

First of all, I would like to thank all of you for affording me the opportunity to comment on Bill No. 270 AN ACT TO AMEND SECTION 3105, OF TITLE 5 GUAM CODE ANNOTATED RELATIVE TO THE QUALIFICATIONS OF THE FIRE CHIEF.

Mr. Chairman and members of this Committee, the Guam Fire Department fully endorses Bill No. 270. Since the retirement of Fire Chief Frank C. Lizama in October 1991, the Guam Fire Department had been without a duly appointed and confirmed Fire Chief. During the past three and a half years the department has had three (3) fire personnel appointed as Acting Fire Chiefs. This practice definitely did not provide the consistency and continuity needed to achieve the department's goals, objectives and mission. What this practice provided was three individuals with different philosophies, thoughts and ideas resulting in the constant change in policies, procedures and goals and objectives. This created confusion and chaos with the ultimate result of low morale amongst employees of the department.

Though any of these three (3) individuals would be an ideal Fire Chief, none of them met the qualification standards as set forth by 5 GCA 3105 relative to the educational requirements of a Bachelor's Degree in the field of Fire Science. As a result of this particular requirement, the island lacked qualified candidates because no educational institution on island offered a Bachelors degree program in the field of Fire Science or Administration.

Not only will the passage of Bill 270 in its present form allow for a sufficient number of qualified individuals for the position of Fire Chief, but will keep intact certain criteria that are required and needed to effectively and efficiently manage a Fire Department.

Mr. Chairman and Committee members, it is our request and desire that this bill be passed

expeditiously so that our department be managed by a qualified, appointed and duly confirmed Fire Chief, which I assure you will result in an effective and efficient department.

Once again, thank you for allowing the Guam Fire Department to present its testimony on Bill 270.
