Enclosed please find a copy of Bill No. 516 (COR), "AN ACT TO AMEND §1101. OF CHAPTER 1 OF TITLE 2 OF THE GUAM CODE ANNOTATED, RELATIVE TO CHANGING THE OFFICIAL NAME OF THE GUAM LEGISLATURE TO ITS NAME IN CHAMORRO LANGUAGE, 'I LIHESLATURAN GUAHAN'", which I have signed into law today as Public Law No. 24-163.

I appreciate the Legislature's effort in promoting Guam's Chamorro language and culture by referring to itself as i Liheslaturan Guahan.

On September 11, 1997, the Executive Branch transmitted a draft bill entitled "AN ACT TO CREATE THE 'KAOHAO GUINAHAN CHAMORRO', OR 'CHAMORRO HERITAGE INSTITUTE'" to the Legislature. The KAOHAO GUINAHAN CHAMORRO is the result of many hours of hard work by the Directors of : the Chamorro Language Commission, the Guam Museum, the Guam Historic Preservation Trust, the Guam Council ont he Arts and Humanities Agency, the Guam Economic Development Authority, the Guam Public Library System, the Department of Parks and Recreation, the Guam Visitors Bureau, and the former Political Status Education Coordinating Commission.

The KAOHAO GUINAHAN CHAMORRO is designed to coordinate the existing agencies, divisions, and commissions which are separately engaged in segments of the unified mission of celebrating and promoting our Chamorro culture and heritage into a cohesive larger organization.

Committee Report on Bill No. 516 "An act to amend Section 1101. Of 2 GCA to change the official name of the Guam Legislature to its name in Chamorro Language, "I Liheslaturan Guahan."

I. OVERVIEW

The Committee on Rules, Government Reform and Federal Affairs held a public hearing on Tuesday, March 10, 1998 at 10:35 a.m. in the conference room of the Chairman of the Committee on Rules, Government Reform and Federal Affairs. Public Notice of the hearing was announced in the March 5th, 6th, 8th, and 10th, 1998 issues of the Pacific Daily News.

II. SUMMARY OF TESTIMONY:

At the request of Dr. Katherine B. Aguon, who could not be present at the hearing, Senator Forbes read Dr. Aguon's testimony **in favor** of the bill (attached). In her written testimony, Dr. Aguon wrote that this bill is long overdue in our efforts to restore and preserve our language, culture and history.

Ms. Catherine T. Bautista, a student at the University of Guam, testified **in favor** of the bill. She stated that people should respect the Chamorro language and culture.

Ms. Carol Guerrero, a student at the University of Guam, testified **in favor** of the bill. She said that efforts must be made to preserve the Chamorro language and culture and it is only right to call the Legislature by its name in Chamorro because the Legislature represents the people of Guam.

Mr. Tony Cruz, a student at the University of Guam, testified **in favor** of the bill. Mr. Cruz stated that using the Chamorro language will remind us of our ancestors and will send the message that the Chamorro language is still alive.

Dr. Rosa Salas Palomo, a professor at the University of Guam testified **in favor** of the bill. Dr. Palomo suggested that a decision be made on the pronunciation of Guahan, with stress on either the first or

the last syllable of the word. Dr. Palomo said that the difference in the stress reflects the origin of the word Guahan and what it means.

Ms. Anna Marie L. Blas, Director of the Chamorro Language Commission, testified **in favor** of the bill. Ms. Blas stated that it is only appropriate that the Legislature be known as I Liheslaturan Guahan because it is here that the laws of Guam are made.

Ms. Tina Delisle, a graduate student at the University of Guam, testified **in favor** of the bill. Ms. Delisle said that the bill is part of a much needed effort to immerse people in the Chamorro culture. She added that a bill like this is critical to augmenting the preservation of the Chamorro language and culture.

Ms. Therese Bamba, a student at the University of Guam, testified in favor of the bill.

Mr. Gregory Perez, a student at University of Guam, testified **in favor** of the bill. Mr. Perez said that if the Chamorro people are not allowed to recognize and take part in the culture there will be systematic destruction of the Chamorro language and culture.

Mr. Robert Cruz, a student at the University of Guam, testified **in favor** of the bill. Mr. Cruz read a letter to the editor printed in the March 7, 1998 edition of the Pacific Daily News. Mr. Cruz disagreed with the author of the letter and stated that there is a direct correlation between exposure and preservation of language and culture. Legislation such as Bill 516 is a good start to preservation.


Ms. Bertha Cruz, a student at the University of Guam, testified **in favor** of the bill. Ms. Cruz said that this is a small step toward preserving the Chamorro language and culture. She added that preservation of the Chamorro culture will come only through strengthening family values and preserving the language.

Ms. Mary Jane Nauta, a student at the University of Guam, testified **in favor** of the bill. Ms. Nauta stated that in order to hold on to the Chamorro culture our children must hear the language.

III. FINDINGS AND RECOMMENDATION

The Committee on Rules, Government Reform and Federal Affairs finds Bill 516, which would mandate that the Guam Legislature be known by its name in the Chamorro language, "I Liheslaturan Guahan," is one of many steps that can be taken in the effort to preserve the culture and language of the people of Guam. The Legislature is the law making body of Guam and is representative of the people. The name we call our Legislature should be a reflection of who we are, the people of Guam. The committee also finds that this move to call the Legislature I Liheslaturan Guahan is an important one toward the preservation of the Chamorro language and culture as it is here that the laws of our island our made. I Liheslaturan Guahan displays for all the value the people of Guam place on their identity.

Accordingly, the Committee on Rules, Government Reform and Federal Affairs, to which Bill No. 516 was referred does hereby submit its findings and recommendations to the Twenty-fourth Guam Legislature **TO DO PASS BILL NO 516** "An act to amend Section 1101. Of 2 GCA to change the official name of the Guam Legislature to its name in Chamorro Language, "I Liheslaturan Guahan."



The above Bill is referred to your Committee as the principal committee. It is recommended you schedule a public hearing at your earliest convenience.

Dear Chairman Forbes,

I am here to testify in favor of Bill Nos. 516, 521 and 522. These bills are long overdue in our efforts to restore and preserve our language, culture and history. Decades of colonial administration and the imposition of foreign ideas and concepts have nearly obliterate our heritage and identity as a people. We have had to rediscover ourselves, our thoughts and ideas. Perhaps, someday, we could restore all that we have lost.

To avoid any potential debate on orthography, "maga'låhin" as written in Bill 521, must be changed to "maga'låhen." The letter \underline{n} , when added to maga'låhi, makes it possessive (governor of); therefore the \underline{i} in this word must change to \underline{e} .

On behalf of those of us who are involved in the preservation of our heritage, I applaud your efforts to introduce the above bills, but more especially, I want to acknowledge all that you have done, and continue to do, to restore and preserve our Chamorro heritage.

I sincerely urge all senators to support Bill Nos. 516, 521 and 522.

Comments to Bill No. <u>516(COR)</u>

As proposed in the Bill, the Bureau anticipates a financial impact to the Government of Guam with respect to printing and other related costs to change all present references of the "Guam Legislature" to "I Libeslaturan Guahan". This impact however, cannot be determined at this time.

The General Fund revenues available for appropriation, as adopted in Public Law 24-59, is \$353,292,790 (includes \$7,600,000 Autonomous Agency Fund, \$7,000,000 Use Tax and \$36,000,000 in Section 30 funds). The appropriations for FY1998 in P.L. 24-59 is \$346,128,092 plus continuing appropriations for debt service of \$2,504,141 for a total appropriation against of \$348,632,234. Pursuant to P.L. 24-59, surplus FY1998 revenues available for appropriations is \$4.6M.

However, it should be noted that the expected combined collection from both the Autonomou: Agency Fund and the Use Tax is only \$3.0M, a reduction of \$11.6M (\$14.6 - 3.0 = \$11.6). As such, \$341,739,919 in revenue less \$348,632,234 in appropriations leaves an <u>expected shortfall of</u> (§6,892,315) as of P.L. 24-59.
