





Public Law No. 24-194

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Section 833 is hereby added to Article 1, Chapter 8 of Title 1
3 of the Guam Code Annotated to read as follows:

4 **"Section 833. George L. Charfauros Baseball Field.** The
5 Pigua Baseball Field in the municipality of Merizo is hereby renamed
6 the '*George L. Charfauros Baseball Field.*'"
