

Dear Speaker Unpingco:

Enclosed please find Substitute Bill No. 685 (COR), "AN ACT TO APPROPRIATE FUNDS TO SUBSIDIZE THE COST OF OFF-ISLAND AIR TRAVEL EXPENSES FOR SPORTS-RELATED ACTIVITIES", which I have signed into law today as **Public Law No. 24-227.** 

This legislation appropriates a total of \$77,000 for Guam Babe Ruth and Guam Little League events which took place in July, 1998. \$50,000 is appropriated to the Guam Babe Ruth Baseball League, to be allocated \$10,000 each to Bambino Minor, Bambino Major, Prep League, Babe Ruth League for 14-15 year olds, and Babe Ruth League for 16-18 year olds. Another \$27,000 is appropriated to the Guam Little League Baseball, Inc. for Champions of the Senior Little League Far East Tournament.

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. Legislative Findings and Intent. I Liheslaturan Guåhån finds 2 that due to Guam's remoteness from regional, national and international venues 3 for sports competitions, it is extremely difficult and costly for local sports 4 organization to plan and participate in such events. Such participation is 5 considered vital and important in fostering the growth, development and 6 advancement of Guam and the Island's residents in a regional, national and 7 global environment. It is especially important for the inspiration and motivation 8 9 of the youths of Guam to develop their full potential and excel in competition 10 and leadership roles.
- 11 Section 2. Appropriations to the Babe Ruth, Prep and Bambino Leagues. 12 Fifty Thousand Dollars (\$50,000.00) is hereby appropriated from the General 13 Fund to Guam Babe Ruth Baseball League, Inc., to be allocated at Ten Thousand 14 Dollars (\$10,000.00) each for: (1) Bambino Minor traveling to West Valley City, 15 Utah on or about July 24, 1998; (2) Bambino Major traveling to Bakersfield, 16 California on or about July 22, 1998; (3) Prep League traveling to La Crescenta, 17 California on or about July 29, 1998; (4) Babe Ruth League (14-15 year olds) 18 traveling to Rohnert Park, California on or about July 29, 1998; and (5) Babe Ruth 19 League (16-18 year olds) traveling to Hanford, California on or about July 29, 20 1998 to supplement the costs of their off-island travel expenses, with the balance 21 to be raised through their fundraising.

#### Section 3. Appropriation to Guam Little League Baseball, Inc.

Twenty-seven Thousand Dollars (\$27,000.00) is hereby appropriated from the
General Fund to Guam Little League Baseball, Inc., for the champions of the

Senior Little League Far East Tournament to supplement their costs and expenses
 at the Senior Little League World Series in Kissimmee, Florida.

3 Section 4. Severability. If any provision of this Law or its application 4 to any person or circumstance is found to be invalid or contrary to law, such 5 invalidity shall not affect other provisions or applications of this Law which can 6 be given effect without the invalid provisions or applications, and to this end the 7 provisions of this Law are severable.

Good Afternoon Senator Tony Unpingco - Speaker of the Twenty-Fourth Guam Legislature; Senator Tony Blas - Vice- Speaker; and Senators of the Twenty-Fourth Guam Legislature

My name is Greg Matanane. I am the President of the Guam Babe Ruth Bambino Minors. This is my testimony in support of Bill No. 685.

We have been invited to participate in the 1998 Pacific Southwest Babe Ruth Baseball Regional Tournament in West Valley City, Utah which will be held July 25th through July 31st.

The participants include 15 young players, ages 9 and 10, and 6 officials.

They have all been working hard since March, what with practices and games every Saturday and Sunday.

Now these 15 players and the 5 officials have been selected to represent the island in the tournament based on their skills as an athlete, their knowledge of the sport, and the positive attitude displayed on and off the fields, which are all important characteristics.

I have been coaching youth baseball for 15 years. As a parent I do this for my children and their friends in an effort to support their social development and to provide them with opportunities and an awareness that there are other things in life that can provide a sense of happiness and fulfillment, to help them deal and to overcome the problems and the pressures that exist today.

I have taken teams off island to represent Guam in tournaments in California and in Japan. When I take teams off-island, it is always my intent for the players to enjoy a satisfying social and cultural experience which will result in new friendships and a lasting memory. Together with the parents and the players, we have been working hard to raise money for the trip. You, as Senators know how difficult that can be when everyone else is also raising money. In fact I am sure that some of you have also made a donation to any one of the teams going off island.

There have been limitations in our efforts, but we have done several things such as lunch plates, raffles, and solicitations to businesses, who are making donations, but there are just too many of us asking at the same time. We are continuing in our efforts, but we are pressed for time and have not raised enough.

To make this trip to Utah would cost about \$31,000. Air fare alone for the players is about \$15,000 and their accomodations would be about \$8,000. As for the officials, their airfare and accomodations is about \$13,000.

In our efforts we have only raised about \$8,000. Of course we will continue to sell raffle tickets and to sell lunch plates and to host dinners or Karaoke nights.

But as you can see, we desperately need your help. Please support us as we take this trip in an effort to provide these young people of Guam an opportunity to display their incredible atheletic skills and their cultural upbringing which we hope will result in the development of their sense of pride in themselves and a sense of achievement. We ask that**y**consider our request for financial assistance.
