"An Act to Add a New Subsection (g) to Section 9 of P.L. 22-13, Relative to Adding a Representative from the Mayors' Council of Guam to the 1999 Guam South Pacific Games Commission"

Public Hearing

The Committee of Power, Foreign Affairs, and General Government Services (P,FA & GGS) held a public hearing on Thursday, March 27, 1997 at 9:00a.m. to hear testimonies on Bill No. 60.

Hearing was called to order by Chairperson of P,FA,&GGS, Senator Felix P. Camacho. Other committee members present were Vice Chairperson Senator Lawrence F. Kasperbauer, Sen. Thomas C. Ada, Sen. Mark C. Charfauros, Sen. Francisco P. Camacho, Sen. Vicente C. Pangelinan, Sen. Carlotta Leon Guerrero, Sen. Alberto A.C. Lamorena, and Sen. Edwardo J. Cruz, MD. Also present were Senator Frank B. Aguon Jr. and Sen. Lou A. Leon Guerrero.

Background

Bill No. 60 was introduced by Senators Francis E. Santos and Vicente C. Pangelinan by request of the Mayors' Council. Its purpose is to add a representative from the Mayors' Council to the 1999 Guam South Pacific Games Commission (SPGC).

Testimony

Present to testify were: Mrs. Tina Rose Muna Barnes, Executive Director of the South Pacific Games Office, and Mr. Randall Cunliffe, Chairman of the 1999 South Pacific Games Commission.

Written testimony was provided and read by Mrs. Tina Barnes. It is in support of Bill No. 60 as it cites two important functions the Mayors' Council of Guam (MCG) will play in the 1999 South Pacific Games (Games). The first of these functions is the MCG's control and maintenance of various sporting facilities needed for the Games. The other role of the MCG will be to coordinate various programs in their villages relative to the Games. (Written testimony attached)

Written testimony was also provided by Mr. Paul M. McDonald, Mayor of the Municipality of Agana Heights, and President of the MCG. It is in support of Bill No. 60 as it is the belief of the mayors and vice mayors of the island that they "can play a vital role in the planning and organization" of the upcoming Games. The testimony also makes references to the mayors' control over "community sporting facilities." (Written testimony attached)

Sen. Felix P. Camacho opened the floor to the Committee for discussion on Bill No. 60.

Sen. Lawrence F. Kasperbauer was concerned over the fact that members of the MCG were not present at the hearing. The MCG's support of Bill No. 60 became an issue.

Mr. Randall Cunliffe clarified that because the Games would require use of facilities under the jurisdiction of the MCG, they requested the introduction of Bill No. 60.

Sen. Felix P. Camacho verified that it was Mayor McDonald who lobbied for support of Bill No. 60, and that the MCG initiated the bill.

Sen. Frank Aguon, Jr. thought the hearing was an excellent time for the SPGC to relay any concerns of the commission involving the Legislature.

Cunliffe acknowledged the necessary correlation between the commission and the Legislature, and the Commission's need for legislative assistance. Mr. Cunliffe proceeded with a brief overview of the SPGC and the Games.

Cunliffe requested an oversight hearing on the SPGC to be held soon.

Discussion of the start date of the Games and its impact on the public school calender took place.

A written statement from the Bureau of Budget & Management Research was submitted requesting that Bill No. 60 be granted a waiver pursuant to Public Law 12-229 because the bill's "proposed measure does not entail a fiscal impact and is administrative in nature." The same statement noted that the preamble of Bill No. 60 refers to the "South Pacific Games Coordinating Council", however, the correct reference should be, "Guam South Pacific Games Commission" as created pursuant to P.L. 22-113. (Request for waiver attached)

Findings

The Committee on Power, Foreign Affairs and General Government Services finds that adding a representative from the Mayors' Council of Guam to the 1999 Guam South Pacific Games Commission will be beneficial in the planning and coordination of the 1999 South Pacific Games.

Recommendation

The Committee on Power, Foreign Affairs and General Government Services wishes to report out Bill No. 60 as substituted by the Committee, and recommends to the full legislature **TO DO PASS.**

The Mayor's Council will play an integral part in the upcoming South Pacific Games because some sporting facilities needed for the games are controlled and maintained by the Mayors, and their assistance in planning is essential.

The Mayor's Council will also be asked to coordinate various programs in their villages. The Adopt-A-Nation Program is an idea to make the visiting delegation feel the hospitality and warmth of the Chamorro people and make them feel at home. Activities will include but not limited to Airport Greeting, Hosting and Fan Support.

The Commission seeks your support and respectfully request that this bill be passed.
