Dear Legislative Secretary Brown:

Enclosed please find Substitute Bill No. 95 (COR), "AN ACT TO ADD §§76222, 76223 AND 76224 TO TITLE 11 OF THE GUAM CODE ANNOTATED, RELATIVE TO REQUIRING TOUR OPERATORS AND OTHER TOURIST-RELATED BUSINESSES TO PUBLISH THE RATE CHARGES FOR ATTRACTIONS, LODGING, AMUSEMENT AND SERVICES RENDERED TO TOURISTS AND OTHER VISITORS", which I have signed into law today as Public Law No. 25-109.

This legislation mandates that the Tour Operators and other tourist-related businesses which sell tours, lodging, amusements, and services to publish the rates that they charge on their premises. While licensing of Tour Operators is done through the Guam Visitors Bureau, this legislation places the enforcement of publishing rates under the Department of Revenue and Taxation. No funding is provided for monitoring this program.

While a good idea, and beneficial to our visitor industry, the better place to monitor posting of rates is through the Guam Visitors Bureau.

(1) fail to publish and post the highest rack/tourist rate schedule of tour attractions, lodging, amusements and services in the place where the attraction, lodging, amusement or service is

6	(3) engage in any act, practice or course of business which

SUMMARY OF TESTIMONY

Dave Tydingco, President of the Guam Hotel and Restaurant Association, provided oral and written testimony in favor of Bill No. 95. He states that Bill 95 concerns those situations in which guests discover that they have paid for an attraction through third party operators, when they would have paid a lesser price by purchasing tickets directly through the box office of the optional tour company. Mr. Tydingco further testifies that these situations create an unfavorable image of Guam and may be detrimental to the Tourism Industry as a whole.

Mr. Tydingco proposes that a list of violators under the provisions of the proposed legislation be provided to the Guam Visitors Bureau and the Guam Hotel and Restaurant Association for disclosure to its members. This would discourage members of both organizations from conducting business with those in violation of the proposed law.

James E. Nelson, III, General Manager for the Guam Visitors Bureau, also provided oral and written testimony in favor of Bill No. 95. Mr. Nelson states that this proposed legislation addresses concerns that have been a central focus for the Tourism Industry over the past several years, especially in the Korean market. He testifies that this legislation is timely in that because the Industry has worked diligently in recent months to regain our position in the Korean market, we must take measure to maintain this share in the market.

Prior to the introduction of Bill 95, Mr. Nelson reports that several tour companies have already begun to post a schedule of rack rates for their product(s). On behalf of the Guam Visitors Bureau, he commends this effort to promote honest business practices within the Tourism Industry.

Joseph Duenas, Director for Department of Revenue and Taxation, provided testimony on Bill 95. Mr. Duenas stated that he supported the intent of Bill 95, however, the role of the Department of Revenue and Taxation, in accordance with the provisions of this proposed legislation necessitates additional duties for its personnel but with no increase in funding level. Mr. Duenas expressed concern with regard to the fact that the Department of Revenue and Taxation would be responsible for the administration of a rate schedule in addition to the monitoring of any violations and the imposition of applicable fees. It is his contention that Rev and Tax has neither the resources nor the funding for this additional responsibility.

Jesse Lujan, Operations Manager for Tarza Magical Adventure Zone, submitted written testimony with regard to his support of Bill 95. Mr. Lujan's primary concern is the current practice of providing *local* (discounted) rates to island residents. He

believes that the posting of a rate schedule will appear to be discriminatory against our visitors. Thus, as per his testimony, Mr. Lujan suggest publishing the *highest rack rate* and tourist rate.

Akiji Ono, President of the Japan Guam Travel Association, submitted written testimony on behalf of the members in the Japan Guam Travel Association (JGTA). Although he states that they support the intent of Bill 95, they have reservations with regard to the implementation of such legislation. He explains that to have each and every tour operator post their prices would be a daunting task. He states that to list all the prices of all attractions would encompass too much wall space at the operator's place of business. Mr. Ono claims that the pricing system is complex and utilizes a specified structure within the Japanese market. Furthermore, Japanese visitors who utilize the services of the operators are provided already with a price list/brochure, and /or have prior knowledge about general pricing information via the Internet, brochures from their travel agents and/or flyers.

For this reason, Mr. Ono suggest that the legislation be amended to state that the *highest* possible prices for attractions and services be placed at the place in which the activity takes place (ie: Sand Castle Dinner Show).

There being no other witnesses, the Chairman then announced that the Public Hearing on Bill No. 95 has been duly publicly heard.

COMMITTEE FINDINGS

The Committee finds that because some businesses and individuals within the Tourism Industry employ undesirable business practices, it is essential to impose certain regulatory measures to curtail any damaging effects such practices may have on Guam as a tourist destination. For this reason, it is necessary to convey an atmosphere of confidence and trust upon tourist who come to Guam to enjoy all that our island has to offer by requiring businesses and individuals engaged as tour operators and other tourist related businesses to publish the rate(s) for accommodations, amusements and services in a schedule to be posted in their place of business. In addition, due consideration must be given to the concerns raised by Mr. Joey Duenas. The process by which the rate schedule is constructed, violations are monitored, and fees are levied requires reassessment.

COMMITTEE RECOMMENDATIONS

The Committee on Tourism, Economic Development and Parks hereby reports out Bill No. 95 to *I Mina' Bente Singko Na Liheslaturan Guåhan* with the recommendation *To Do Pass, as Substituted by the Committee*.

Hafa Adai Mr. Chairman, Members of the Committee:

My name is David B. Tydingco, President of the Guam Hotel & Restaurant Association, and I am here to testify in support of Bill No. 95.

At the present time, Guam's InnKeepers Law requires hotels to post their accommodation rates in a conspicuous area. These rates are typically posted in the rooms of hotels for guests to read. Therefore, to require hoteliers to publish these rates may be redundant. With regard to tour operators, a majority of the guests coming to Guam from our major markets buy packages, which, at the very minimum, is inclusive of airfare and accommodations.

With respect to restaurants, the prices for meals are included in a menu, and therefore this legislation should not impact our restaurant industry.

The main concern of our visitor industry, based on passed experience, is related to local land operators charging more than the "rack rate" for optional tours. The "rack rate" is typically the fee charged to walk-in customers. In the past, it has been Guam's experience that some local ground operators would charge anywhere between 25% to 50% more than the rack rate, even though the same land operators would buy the optional tour at a substantial discount from the optional tours. This situation has created problems in the past when guests would find out that they paid more for the optional tour through the land operator rather than simply walking up to the box office of the optional tour and purchasing it directly.

Therefore, the Guam Hotel & Restaurant supports the intent of Bill No. 95 which requires tourist related businesses, primarily optional tours, to post their rates in a conspicuous area for guests to easily see and read.





Testimony of James E. Nelson III, General Manager Guam Visitors Bureau on Bill No. 95 Monday, July 26, 1999

Håfa Adai Chairman Lamorena and members of the Committee on Tourism, Economic Development and Parks. Thank you for the opportunity to present testimony on Bill No. 95: An Act to Add Sections 76222, 76223 and 76224 to Title 11 of the Guam Code Annotated, Relative to Requiring Tour Operators and Other Related Businesses to Publish the Rate Charges for Accommodations, Amusement and Services Rendered to Tourist and Other Visitors in a Schedule to Be Posted in the Place of Their Business.

First of all, I extend my thanks to you, Mr. Chairman, for introducing Bill No. 95. As you are well aware, discussion on this subject has been ongoing for a number of years now. The underlying reason for it all is the negative impact that Guam's tourism industry received a few years ago, especially in the Korean market.

Prior the unfortunate Korean Air crash, Guam's image in Korea was an affordable place to go, but very expensive once you get here. Those of us in the tourism industry were very concerned and gathered information that led us to believe that there were several land operators who were pricing optional tours at well over 200%, and in some cases 300%. At the time, Mr. Chairman, Guam was not an isolated incident. My counterparts in Hawaii and Australia also voiced the same concern in there respective destinations. This condition still exist at these destinations.

Immediately after the Korean Air crash, what became evident was that those land operators who delved in such unethical practices, for all intents and purposes, disappeared.

Mr. Chairman, we have spent an enormous amount of time and money to rebuild the Korean market to a point where the market is practically doubling in size. We foresee the Korean market reaching its pre-crash numbers of close to 200,000 visitors in the next 18 to 24 months. Bill No. 95 could not have come at a better time.

Dear Senator Lamorana.

Thank you for the opportunity to comment on your proposed Bill 95, scheduled for legislative hearing next week.

Although we support the intent of the proposed legislation we are against the implementation aspect of Bill 95. The main reason is the complexity and the structure of pricing that currently exist in the Japanese tour market. To display the various tours and their respective prices will take up an immense amount of wall space at each of the already overcrowded tour desks, located in the hotel lobbies. Additionally, all the Japanese visitors who participate in optional tour activities have been provided a booklet (menu) that provides in detail the cost of the tours. The Japanese tourist also has access to pricing prior to their arrival on Guam via both the Internet and through Japan based Retailers and Wholesalers manuals and flyers.

One solution that has been offered would be to publish the rates at the place where the optional tour activity is being conducted. An example would be, if a tourist purchased a ticket for the Sandcastle Dinner Show, when they arrived at the Sandcastle they would have the opportunity to see the published rate. Another comment deals with the various prices that are offered. Optional tour sales are incentive driven on Guam and the pricing is proprietary information from one tour agent to another. We would recommend that in the event the law be passed that only the highest price of a tour is published.

As the intent of Bill 95 is to protect tourist from price gouging by unscrupulous tour operators we believe the above course of action would provide that protection. Should you require any additional information I am available at your convenience.
