

#### Committee on Land, Agriculture, Military Affairs & the Arts

#### Committee Report July 18, 2000

The Committee on Land, Agriculture, Military Affairs & the Arts held a public hearing on July 18, 2000 at the Public Hearing Room in the Legislative Building. The hearing was called to order at 9:00 a.m. by the Chairman, Senator Marcel G. Camacho.

Present for the hearing were Senators Lawrence Kasperbauer, and Senator Ben Pangelinan.

**BIII NO. 433 (COR):** AN ACT TO AMEND SECTION 2 AND SECTION 3 OF PUBLIC LAW 24-316, RELATIVE TO CORRECTING TECHNICAL ERRORS IN THE REFERENCE OF APPROPRIATE LOT NUMBERS.

#### **Testimony Submitted by:**

David Su Oral

#### **Summary of Testimonies:**

The Chairman read Bill No. 433 (COR) and noted that it was introduced by Speaker Unpingco and himself. It was presented to him that an error occurred in P.L. 24-316 when referencing a lot to be exchanged. The original legislation referenced Lot Nos. 5051-R2 and 5052-5 in Tumon.

David Su, the owner of the lots, stated that a bill was passed and put into law to exchange a piece of the bullcart trail with the neighboring lot so that the two lots could be consolidated, and that land would be given to the government for its own use. However, during the making of the map, the surveyor noticed an error in the lot numbers. Mr. Su presented the map and referenced the lots in question.

The Chairman stated that this legislation just identifies the correct lot.

There being no other testimony, the bill is publicly heard.

Committee findings and recommendations: The Committee finds that Lot 5052-5 is currently bounded on the south by Lot 5058-2; on the west by San Vitores road; on the north by San Vitores road and on the east by the abandoned Bull-cart trail. Lot 5051-R2 is currently bounded on the south by Lot 5058-2; on the west by the abandoned Bull-cart trail; on the north by San Vitores Road and on the west by Lot 5058-3. The Bull-cart trail bisects Lot 5052-5 and the western boundary of Lot 5051-R2. The Bull-cart trail is both the eastern boundary of Lot 5052-5 and the western boundary of Lot 5051-R2.

The committee further finds that it was the intent of 1 *Mina' Bente Kuattro Na Lehislaturan Guahan* to approve the land exchange to allow the owner to consolidate Lot 5052-5 with Lot 5051-R2. Public Law 25-316 continues to have the Bull-cart trail as the eastern boundary of Lot 5052-5 and the western boundary of Lot 5051-R2.

The landowner is still not able to consolidate his lot. **The Committee recommends** that Public Law 24-316 be amended to authorize the exchange of the abandoned Bull-cart trail with property of equal size located on the eastern boundary of Lot 5051-R2.



AN ACT TO AMEND §§2 AND 3 OF P.L. NO. 24-316, RELATIVE TO CORRECTING THE REFERENCE OF LOT NUMBERS FOR LAND EXCHANGES WITHIN THE MUNICIPALITY OF DEDEDO, VILLAGE OF TUMON, GUAM.

### 1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan has
- 3 been informed by the owner of Lot Numbers. 5051-R2 and 5052-5 that a
- 4 technical error was made in §§2 and 3 of Public Law Number 24-316. The

1 owner of said lots proposed that the bull-cart trail be exchanged for land on

2 the eastern-most boundary of Lot Number 5051-R2, rather than Lot Number

3 5052-5. The existing language in Public Law Number 24-316, with the

technical error, does not facilitate the land exchange and defeats the purpose

5 of the original legislation.

6 **Section 2**. Section 2 of Public Law Number 24-316 is hereby *amended* to 7 read as follows:

"Section 2. Authorizing Exchange. I Maga'lahen Guåhan is authorized to exchange a portion of the abandoned pre-war bull-cart trail between Lot Numbers 5051-R2 and 5052-5, in the Municipality of Dededo, Village of Tumon, Guam for a land area equal to the bull-cart trail on the eastern-most boundary of Lot Number 5051-R2 in the Municipality of Dededo, Village of Tumon, Guam. The title of this new lot shall be deeded to the Chamorro Land Trust Commission."

**Section 3**. Section 3 of Public Law Number 24-316 is hereby *amended* to read as follows:

"Section 3. The Chamorro Land Trust Commission shall accept the dimensions of the resulting lot at the exact location of the lot within Lot Number 5051-R2 in the Municipality of Dededo, Village of Tumon, Guam in order for the exchange to be valid."
