Dear Speaker Unpingco:

Enclosed please find Bill No. 224 (COR), "AN ACT TO AMEND §6(b) OF P.L. NO. 21-91, RELATIVE TO CORRECTLY IDENTIFYING THE LEGAL LOT DESCRIPTIONS OF PROPERTY SOLD TO MR. MARK V. PANGILINAN", which I have signed into law today as Public Law No. 25-58.

This legislation is designed to correct the identification of small lots which are to be sold to Mr. Mark V. Pangilinan. These lots are located at the site of the new federal courthouse building on Marine Drive.

Unfortunately, the Guam land in question is not yet registered land. At the present time, the government is registering the land so that a clear title can be had. The current lot designation for the exchange land still needs clarification.

In item (i) contained in Section 6(b) of Section 2 of the legislation, page 2, a specific description of "that parcel, containing approximately eighty (80) square meters, situated between Lot Numbers 1045-1-1 and 1458-1, Hagåtña, Guam" is omitted. What parcel is the legislature trying to identify?

Also, in item (ii) contained in the same section, same page, a description has been inserted which is not an official description. A proposed lot number on a new survey is inserted, but a reference should be made to the currently official number of the lots, also. The beginning sentence of

item (ii) should make reference to "The alley between Lot No. 1451-1-1 and 1451-3 and 1451-2-2, within Lot No. 19 and Lot No. 22 of Block 10, New Agana, now designated as Lot Number 2073, Municipality of Hagåtña, Guam containing an area of  $51\pm$  square meters. . . "

The new description is a proposed description, and not official according to land registration proceedings or Department of Land Management records, even though a proposed map has been filed.

## 1 BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan
finds that §6(b) of Public Law Number 21-91 authorized I Maga'lahen Guåhan
to sell substandard government lots to Mr. Mark V. Pangilinan. The lots of
interest are located where the Federal District Courthouse is being
constructed. I Maga'lahen Guåhan, pursuant to the authorization in Public

Law Number 21-91, sold the property to Mr. Pangilinan, who paid the sum of
 Twenty-five Thousand Four Hundred Eighty-eight Dollars (\$25,488.00) for the
 said lots on May 5, 1993. *However*, a technical error in the lot description
 prohibited Mr. Pangilinan from obtaining title to the property.

5 Obtaining the title to the property is essential for Mr. Pangilinan in 6 order for him to obtain permanent financing for the Federal District 7 Courthouse. It is the intent of *I Liheslaturan Guåhan* to amend §6(b) of Public 8 Law Number 21-91 to properly reflect the correct legal lot description.

9 Section 2. Section 6(b) of Public Law Number 21-91 is hereby *amended*10 to read as follows:

#### "Section 6(b). Authorization to Sell Hagåtña Parcels. I

12 Maga'lahen Guåhan is authorized to sell to Mr. Mark V. Pangilinan, the 13 owner of the adjacent lots, the following alleyways and substandard 14 parcels of government land in Hagåtña, Guam: (i) that parcel, 15 containing approximately eighty (80) square meters, situated between 16 Lot Numbers 1045-1-1 and 1458-1, Hagåtña, Guam; and (ii) Lot Number 17 2073, Municipality of Hagåtña, Guam, containing an area of 51± square 18 meters, all as shown and described on Map Drawing Number RRV-92-19 019, prepared by Mr. Roberto R. Ventura, R.L.S. Number 54, dated 20 January 10, 1993, and L.M. No. 528, F.Y. 92, a copy of said map is 21 recorded in the Department of Land Management, government of 22 Guam on April 15, 1993, under Instrument Number 487466, all situated 23 in the Municipality of Hagåtña, Guam (collectively "Property"); provided, however, that such sale shall not include any portion of those 24





#### Testimony provided by:

Robert R. Ventura, Registered Surveyor

**Mr. Ventura:** I am here on behalf of Mr. Pangilinan. On PL 21-91 there was a typographical error in describing the adjacent lots to the subject lot that was sold to Mr. Pangilinan. Now we would like to amend that to read Lot No. 2073, which is described on a map prepared by me, drawing #RRV-92-019 dated 1/10/93, DLM# 528. In PL21-91 this particular lot was described that contains an area of 50 square meters. I believe at that time they were using a record description of the lot, but when the lot was actually surveyed lot there was 1 square meter difference (51 sqm.). This is the only living government lot in that area and Mr. Pangilinan need the title so that he can gain financing on that Federal Court Bldg.

(Oral)

**Sen Camacho:** So what this bill does is just more explicitly identifies the lot and corrects a technical error.

Mr. Ventura: Yes, because it has been surveyed and duly recorded at DLM.

**Sen. Camacho:** I do have a copy of the map that was submitted by Mr. Pangilinan and it will be provided to everyone in the committee report.

Sen. Camacho: Thank you for your testimony on Bill No. 224.

No. 54, dated January 10, 1993, and L.M. 
