AN ACT REQUIRING DPW TO RECONCILE AND PRORATE ARREARS OF RESIDENTIAL TIPPING/USER FEES FOR THE PERIOD OF FEBRUARY, 2000 TO MARCH, 2001.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan*finds that the Department of Public Works ("DPW") has been inconsistent in
billing residential generators of solid waste between the months of February,
2000 to March, 2001. *I Liheslaturan Guåhan* also finds that DPW intends on

assessed until all of the provisions of this Section are completed, and back
 billing shall *not* exceed seven (7) months.

3 Section 3. Effective Date. The provisions of this Act shall take effect
4 *immediately* upon enactment into law.

5 Section 4. For all services incurred subsequent to June, 2001, back
6 billing shall *not* exceed four (4) months.

7 Section 5. Severability. *If* any provision of this Law or its 8 application to any person or circumstance is found to be invalid or contrary to 9 law, such invalidity shall *not* affect other provisions or applications of this 10 Law which can be given effect without the invalid provisions or application, 11 and to this end the provisions of this Law are severable.

I. <u>PUBLIC HEARING</u>

BILL NO. 5 (COR) was introduced on January 9, 2001 and referred to the Committee on Public Works, Health and Human Services ("the Committee") on February 9, 2001. A Fiscal Note was requested from the Bureau of Budget and Management Research on January 29, 2001 and received February 27, 2001. (Herein attached as <u>"Exhibit A"</u>.)

The Committee called a public hearing to order at 9:10 a.m., Tuesday, February 27, 2001 to hear testimony on **BILL NO. 5 (COR)**. The hearing was held in the Public Hearing Room of *1 Liheslaturan Guåhan* in *Hagåtña*. Notices were placed in the Pacific Daily News in compliance with mandates regarding notification of public meetings.

The hearing was called to order by Senator Eddie Baza Calvo, Chairman of PWH&HS, with Senators Thomas C. Ada, Frank B. Aguon, Jr. and Lou Leon Guerrero in attendance.

II. <u>TESTIMONY</u>

DEPARTMENT OF PUBLIC WORKS

- Funding for the Solid Waste Division of the Department of Public Works ("DPW") is supposed to come from the tipping/user fees with an original estimate of \$6 Million to be collected (\$3 Million from residential customers \$3 Million from commercial generators).
- Currently, an estimated 26,000 residential customers are being billed for solid waste collection with 5,000 customers not yet billed.
- Tipping/User Fee billings are generated out of the Department of Administration ("DOA") with DPW only administering the mailing of the billings.
- The most current information given to DPW by DOA on the amounts collected in tipping/user fees was for the period of August 1999 through August 2000, with a total of \$2.9 Million collected (\$291,000.00 for residential customers and approximately \$2.7 Million from commercial waste haulers.) The department did not have the figures of the amounts collected from the "lump sum" billing (10 months of service) when queried by the Chair.
- The Solid Waste Division has been able to remain in operation because of transfers made by the Bureau of Budget & Management Research ("BBMR"). And with a budget of approximately \$5 Million from BBMR, it is anticipated that a shortfall of \$900,000.00 will occur as the result of the expenditures incurred from the rental of equipment used for the daily covering of the landfill.
- The option of contracting out the accounting aspect of tipping/user fees (billings) has been discussed within the division/department.

SENATOR EDDIE BAZA CALVO

• The inaccuracies and inefficiency of the entire administrative and accounting functions of the tipping/user fees must be immediately addressed. A comprehensive reconciliation of accounts must also immediately begin, with credit applied to those customers who have already paid tipping/user fees. At the same time, credit should be applied to those accounts for which solid waste pick up did not occur. Residential customers should not be forced to pay for a comprehensive retroactive billing because of the department's inefficiencies, but should be afforded an opportunity to pay within a means that they can afford.

SENATOR THOMAS C. ADA

• If back-billing is going to occur, residential customers should only be billed for the last four billing periods, and not for services rendered since the inception of the tipping/user fee program.

SENATOR LOU LEON GUERRERO

• If the department administering the program had total control of its operations the entire system would be more efficient. Suggested that options be considered, such as having DPW handle the billings or having a private contractor do the same. Requested that the Committee hold roundtable discussions regarding the matter.

SENATOR FRANK B. AGUON, JR.

• Currently, without the transfer of funds into the division, the department would not be able to function and it is critical that the department be aware of all aspects of budgeting, billing and collections in relation to the tipping/user fees.

There being no further testimony, the public hearing on Bill No. 5 (COR) concluded at 10:10 a.m.

III. <u>FINDINGS</u>

The Committee finds that the Department of Public Works has been inconsistent in billing residential customers since the inception of the tipping/user fee program. The Committee also finds that the cumulative lump sum billing for residential accounts (deemed in arrears) ceased shortly after the public hearing was held, and that DPW now intends on issuing a cumulative billing for the months of February 2000 to March 2001. The Committee further finds that residential customers should not be unduly penalized for the department's inefficiency and said customers should not be required to make a lump sum payment for fourteen (14) months of service. Moreover, the Committee finds that a reconciliation must be immediately performed on all residential customer accounts and that credit be applied to those customers that have paid for services rendered. Credit should also be applied to those customers who were not serviced during the fourteen month period. After the reconciliation is performed, each customer's arrears balance should be prorated in the billing cycle following the completion of the reconciliation of the reconciliation and should be divided into twelve equal monthly installments.

IV. <u>RECOMMENDATION</u>

The Committee on Public Works, Health & Human Services does hereby report out <u>SUBSTITUTE</u> <u>BILL NO. 5 (COR)</u>, to *l Liheslaturan Guåhan*, with the recommendation **TO DO PASS**.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan 3 finds that the Department of Public Works has been inconsistent in billing 4 residential generators of solid waste between the months of February 2000 to 5 November 2000. I Liheslaturan Guåhan also finds that the department intends on assessing individual residential generators the aggregate sum of 6 7 residential tipping/user fees for which it deems is in arrears. I Liheslaturan 8 Guåhan further finds that residential generators should not be unduly 9 penalized for the department's inefficiency and said generators should not be required to make a "lump sum" payment for ten (10) months of service. It is 10 the intent of I Liheslaturan Guåhan to prevent the Department of Public Works 11 12 from issuing such a cumulative, lump sum billing and ensure that residential 13 generators are afforded the opportunity to pay for arrears within a reasonable time frame. 14
