Dear Legislative Secretary Brown:

Enclosed please find Substitute Bill No. 092 (LS) entitled: "AN ACT TO AMEND §§ 6103 AND 6104, AND TO ADD § 6105.1 TO TITLE 17 OF THE GUAM CODE ANNOTATED, RELATIVE TO TESTING UNDERAGE ENTRANCE INTO KINDERGARTEN AND TO ADD A SUNSET PROVISION" which I have signed into law as Public Law No. 26-29.

This legislation contains provisions that are inconsistent with the provisions of Bill No. 001, passed in the same legislative session and which is now Public Law No. 26-26. Please note that new Section 6106 of Public Law No. 26-26 will now need to be repealed, as it provides for options to again change the date for entrance to kindergarten.

The consensus of opinion among educators of young children is that early entrance into kindergarten for children who may at times be very intelligent but who are nevertheless immature in other ways due to their chronological age does not serve those children well in future years. Their later performance does not compare well to those of older children in the class in which these younger children are placed.

Since this legislation establishes a firm cut off date of July 31st for future years for the entrance of children into kindergarten, this legislation is signed.

Any such 22 child whose parent(s) request screening for entrance into kindergarten 23 under the provisions of this Section at least thirty (30) days prior to the 24 start of the school year shall be screened, and upon passing, deemed

eligible to be admitted on a space-available basis. Space availability
shall be based on the class size limits as determined by Department
policy. In the event that space is available in a class, but the number of
eligible students exceeds such available space, first priority for
admission shall be determined based on age, beginning with the eldest."
Section 3. Section 6105.1 is hereby added to Article 1, Chapter 6,
Division 2 of Title 17 of the Guam Code Annotated to read as follows:

8 "Section 6105.1. Sunset Provision Underage Screening and 9 **Enrollment**. Notwithstanding the provisions of §§ 6103 and 6104, 10 beginning with the School Year 2002 – 2003, all students must be at least 11 five (5) years of age by July 31 of each year for enrollment in 12 kindergarten for that school year. The Department of Education shall 13 announce the starting date for schools at least one hundred eighty (180) 14 days in advance of the starting date. There shall be no further screening 15 for underage enrollment in kindergarten after the School Year 2001-2002." 16

Committee Report On

Bill No. 92 (LS): AN ACT TO AMEND §6103 AND 6103.1 OF TITLE 17, GUAM CODE ANNOTATED RELATIVE TESTING FOR UNDERAGE ENTRANCE INTO KINDERGARTEN.

I. OVERVIEW

The Committee on Education held a public hearing on Friday, June 1, 2001 at 9:00 a.m. at I Liheslaturan Public Hearing Room.

Providing Testimony on the Bill:

II. Testimony

Joint Testimony - DOE Administrators and Teachers

Testimony was presented on behalf of eighteen elementary school administrators in opposition to the Bill. Issues cited were:

- Shortage of teachers certified in early childhood education.
- DOE projection that about four hundred additional of age kindergartners will enroll in school this upcoming school year.
- This will put a substantial strain on DOE resources.
- Experience has shown that children who are not five years old at the start of the school are at a continuous disadvantage.
- The assessment tool used to determine readiness for school has been compromised and must be replaced. This and test administration will be costly.

H. Joseph Dobrowolski, Principal, Price Elementary. Mr. Dobrowolski testified against Bill No. 92 He reviewed the positive aspects of the recent raising of the minimum school entry age. He recommends a firm cut-off date for both eligibility age and student registration. Also, he recommends elimination of early entrance testing and the space available provision of Bill No. 92.

Glenna Reyes, Principal, Chief Brodie Elementary. Ms. Reyes submitted testimony opposing Bill No. 92 citing statistics which show benefits of children starting school at five years of age and problems associated with early entrance.

Ms. Shirley Marsh: Ms. Marsh testified as a proponent of children being five years old by the time they enter school; otherwise they are not ready for school. She suggests doing away with testing as it does not determine maturity.

Ms. Eugenia Manley: Ms. Manley stated that her child will be five years old in November of this year. She asked the school administrator that the child be tested, but her request was denied. She asks that the eligibility date either be extended or that her child be tested.

Ms. Norma Tabayoyong, Principal, M.A. Ulloa Elementary School: Ms. Tabayoyong informed the Committee that her school policy requires pre-registration of students by July 15, 2001. This helps with the planning process and preparation for accommodating students. She stated also that her school does not have the capability to screen students, but her experience has

been that out of seven schools in her region, four out of twenty-three children passed screening and were enrolled. These children, however, are not performing well in school.

Ms. Victoria Carrera, Teacher and Parent: Ms. Carrera related that her grand daughter is six days short of the birth date cut-off. The child has attended pre-school for two years, yet is ineligible for kindergarten. There exists a two year cap on pre-school attendance leaving the child ineligible for either program. Ms. Carrera also suggests that a firm date be established for kindergarten eligibility.

Ms. Teri Knapp, GATE Coordinator: Ms. Knapp clarified the issue surrounding the cut-off date used for the GATE Program and suggested that a firm cut-off date for kindergarten would enable parents to plan for their children's schooling.

Ms. Jan Yamashita, DOE Associate Superintendent of Elementary Schools. Ms. Yamashita stated that DOE will screen children but that priority must be given to enrolling children who are five years old at the start of school. Experience has shown, she said, that eligible students often enroll after school has started and must be accepted. Overcrowding results, she stated, and grievances are filed by teachers.

Dr. Nerrissa Schafer, DOE Administrator of Research, Planning and Evaluation. Dr. Schafer responded to concerns raised over the projected increase in kindergarten enrollment for the upcoming school year by explaining the methodology used in arriving at the figure.

Ms. Rose Rios, DOE School Administrator. Ms. Rios stated that experience has shown that four year olds are too young to attend school. She further stated that it is a form of rejection for a child to pass screening and not be allowed to enroll due to space limitations. Also, of those screened, nine out of ten are rejected. This, she said, is damaging to the child's self-esteem.

Ms. Marsha Burch, Kindergarten Teacher. Ms. Burch testified that she is a proponent that children being five years old at the start of school. She stated, also, that there is a loophole in the screening system in that students fail screening at one school and then go to another school for testing armed with knowledge of the test contents. She suggests that a central testing facility be established.

Ms. Jane Rayphand, Kindergarten Teacher. Ms. Rayphand is a twenty-year veteran teacher representing herself and six other teachers who want a firm cut-off date for age eligibility. This, she stated, would end the turmoil associated with kindergarten enrollment. Her experience has shown that screened early entrants generally do not perform well.

III. Findings and Recommendation

Considering the testimony presented at the hearing on Bill No. 92, the concerns of parents expressed to the Committee, and the Committee research on the issue at hand, the Committee finds that establishing a firm age eligibility date for entrance into kindergarten would best serve the interests of children, their parents, their teachers and school administrators.

Many parents, however, have planned their children's schooling around the provisions of existing law which allows for early entrance screen. The Committee finds that, in fairness to those so affected, the screening process should be allowed for the upcoming school year but eliminated thereafter in favor of a firm cut-off date with no early entrance. Discussions subsequent to the hearing on the Bill with DOE officials indicate that this is acceptable to DOE. Of all elementary school principals polled, agreement is unanimous.

It is, therefore, the recommendation of the Committee to substitute Bill No. 92 to reflect the aforementioned changes and that Substitute Bill No. 92 be reported out of the Committee with the recommendation **TO DO PASS**.

From: Principal

Having received and reviewed a copy of Bill No. 92, I respectfully submit the following suggestions and comments:

I do not support the bill. Several years ago, the Legislature was requested to pass a law raising the age of the island's public school children entering Kindergarten. The request came from the educators nearest to Kindergarten students, their teachers. Aimed with both years of experience and the latest research, they asked that the minimum age be raised to five. American research showed that students entering Kinder earlier met with less success, both in their first year at school and throughout the following twelve years. Differences in social readiness and physical development were suggested as reasons for differences – fine and gross motor skills development, emotional maturity/stability, leadership, etc.

The age was raised in the best interest of our children, not due to shortages of teachers, classrooms or to cause parents the inconvenience of needing an extra year of daycare. Other reasons might have also included how we locally judged the success of our island's public schools – on national test results. Those tests, prior to the enactment of the law raising entrance age, compared apples and oranges, as our children were entering school much earlier than the national average. Our first group of "older" students were tested as First graders two years ago. The results were that Guam's students, for the first time, met or exceeded the national average. These first results suggest the law's intent was correct. Our second group of "older" students was tested last month; the results of that test will not be available until August 2001.

My suggestions would be to provide stability and consistency to both the public (parents) and the public school system by enacting the following:

- 1 Establish a HARD cut off date rather than the current floating one perhaps 31 July or 31 August rather than the first day of school based on an annually changing calendar.
- Establish a HARD "must register by date" for Kindergarten perhaps 15 June or 1 July. Parents who did not register their children by that date, without cause, would be subject to educational neglect prosecution. Kindergarten planning remains the greatest uncertainty each year for our public schools; how many classroom and teachers will be needed at each school is never finalized until AFTER school begins. In SY1999-2000, Guerrero's need grew from six to eight Kindergarten classes between a week before school began and a week after. An eighth teacher was not obtained until well into the second quarter. In SY2000-2001, Guerrero's need dropped again to six classrooms. In SY2000-2001, Price's need likewise grew from six to eight Kindergarten classes (132 students) in the two weeks surrounding the first day of school. The eighth teacher was not obtained until January in third quarter after UOG's December graduation. Currently Price, after three weeks of community advertising requesting parents register their children "today," has only 20 students registered.

Having received and reviewed a copy of Bill No. 92, I respectfully submit the following suggestions and comments:

I do not support the bill. Several years ago, the Legislature was requested to pass a law raising the age of the island's public school children entering Kindergarten. The request came from the educators nearest to Kindergarten students, their teachers. Aimed with both years of experience and the latest research, they asked that the minimum age be raised to five. American research showed that students entering Kinder earlier met with less success, both in their first year at school and throughout the following twelve years. Differences in social readiness and physical development were suggested as reasons for differences – fine and gross motor skills development, emotional maturity/stability, leadership, etc.

The age was raised in the best interest of our children, not due to shortages of teachers, classrooms or to cause parents the inconvenience of needing an extra year of daycare. Other reasons might have also included how we locally judged the success of our island's public schools – on national test results. Those tests, prior to the enactment of the law raising entrance age, compared apples and oranges, as our children were entering school much earlier than the national average. Our first group of "older" students were tested as First graders two years ago. The results were that Guam's students, for the first time, met or exceeded the national average. These first results suggest the law's intent was correct. Our second group of "older" students was tested last month; the results of that test will not be available until August 2001.

My suggestions would be to provide stability and consistency to both the public (parents) and the public school system by enacting the following:

- 1 Establish a HARD cut off date rather than the current floating one perhaps 31 July or 31 August rather than the first day of school based on an annually changing calendar.
- Establish a HARD "must register by date" for Kindergarten perhaps 15 June or 1 July. Parents who did not register their children by that date, without cause, would be subject to educational neglect prosecution. Kindergarten planning remains the greatest uncertainty each year for our public schools; how many classroom and teachers will be needed at each school is never finalized until AFTER school begins. In SY1999-2000, Guerrero's need grew from six to eight Kindergarten classes between a week before school began and a week after. An eighth teacher was not obtained until well into the second quarter. In SY2000-2001, Guerrero's need dropped again to six classrooms. In SY2000-2001, Price's need likewise grew from six to eight Kindergarten classes (132 students) in the two weeks surrounding the first day of school. The eighth teacher was not obtained until January in third quarter after UOG's December graduation. Currently Price, after three weeks of community advertising requesting parents register their children "today," has only 20 students registered.

- 3 Eliminate parent uncertain caused by the "expectations" legislating an early entrance testing mandate which violates the current school age attendance law (5 to 16 years old, not 4 years old) would raise.
- 4 Eliminate the planning uncertainty caused by a "space available to the oldest 4 year old" list by this mandate.

I hope these comments and suggestions help focus attention on our children's success rather than the inconvenience parent's experience in securing quality daycare. I wish to thank you for listening to the professionals in the past by passing a mandatory age law and thank you in advance for listening to them again to keep it. We thank you for inviting the Guam Department of Education to participate and provide input on Bill NO. 92. In response to this bill to amend § 6103 and 6103.1 of Title 17, Guam Code Annotated Relative Testing for Underage Entrance into Kindergarten, we, the Principals, submit our position.

In 1998, the Guam Legislature enacted Public Law 24-26 establishing the entrance requirement for students entering Kindergarten. Since the passage of this law, the Department continues to meet major challenges in its recruitment efforts to hire certified early childhood majors to fill the vacancies. At the beginning of each school year, the Department is faced with the inevitable reality in which the University of Guam is not graduating enough teachers in the field of education to fill all vacant positions from Kinder to 12th grade.

The passage of Bill NO.92 will only exacerbate the already lack of certified teaching personnel. The mandated screening provides false hopes to parents that the Department will enroll their child into kindergarten.

Additionally, the Agreement between the Guam Federation of Teachers Local 1581 AFT/AFL-CIO and the Territorial Board of Education for Teachers mandates the Department to provide instructional aides to assist teachers in the classroom. The Department anticipates a projected kindergarten enrollment of approximately four



hundred more students district-wide. The increase of student enrollment requires additional classrooms and resources. The influx of students will substantially cost the Department additional thousands of dollars.

Senator, if we may, let us go back a couple of years when December 31 was statutorily designated as being the cut-off date. This had raised grave concern by the Kindergarten teachers and school principals, causing you to address this key issue with the present law.

Nationally, a number of schools have the last day in August as a cut-off date for students to enter kindergarten. Teacher reports, observations, and other data have indicated that students who turned five by August perform better than those born later. You recognized the significance of those months because you attempted to address the disparity by enacting into law that a student must be five (5) years old on the first day of school and designating August 7th as the cut-off date. The August 7th cut-off date applies to both traditional and year round schools.

A couple of months ago, the school principals met and discussed extensively the early entrance issue and voted unanimously to reject any early entrance registrant who did not meet the statutory entrance requirements. Bill NO.92 today appears to undermine all the efforts of past years to maintain a creditable cut-off date that would allow for not only fair competition in terms of norming, but most importantly, to insure that children entering kindergarten are maturately and socially ready when they enter kindergarten. If you remember, kindergarten teachers inundated your office with their concerns in eliminating the December 31 because they experienced that children born after August were found to be very immature and cognitively not ready for school. Some of the behavioral characteristics of these children could be described to have come to school crying, clutching to their mother's skirts, and other noticeable indifferent behaviors that continued into the middle of the school year.

Teachers continued to observe these late bloomers to not fit in socially with those born earlier. As a matter of fact, a review of test scores and teacher observations show that these students, as they progress through the grades, do not perform well in comparison to the students born in August. We have already seen that those first graders who were five the first day of school were more successful as indicated on the increase of our SAT9 test results.

The assessment tool used has to be replaced since it has been widely circulated and children can be conditioned to pass the test. It no longer provides a true assessment of the students' cognitive ability. It does however indicate through the testing process if a child is mature enough for kindergarten. Other than replacing the assessment tool, teachers who are presently on their summer break will have to be requested to administer the test, requiring the Department to expend additional money.

The concerns of our teachers have not changed. What has changed is that politicians have not accepted sound educational recommendations made by professionals in the field. What happened that you adamantly have become insistent on the schools testing students for early entrance contrary to what professional experts have suggested. Do not subject our students to venture into a situation where they will be discouraged and frustrated in their schooling.

This past year, teachers in the middle of the school year filed grievances because their class size exceeded 18 students contradictory to Board/Union Contract. Students continue to be transient throughout the school year and classrooms that initially began with 17 at the beginning of the year normally increased over 18 by November and/or December.

To test students for early entrance would only mislead parents to think that their child would subsequently be enrolled in school. For whatever reasons parents have come to you expressing their concern to compel the schools to screen test their child, we ask that you respect and honor the decision made by us, the experts and practitioners in the field. We implore you to trust us and let us do our job of teaching and learning. Leave the students with capable, dedicated, hard-working teachers because we know best and we have the students best interest at heart. You ardently believe a site-base management concept or model best work at the school level, we challenge you now to manifest your belief and principles by honoring our decision.

Irrespective of the cut-off date, you will always have parents who will say that their child is only one day short of meeting the entrance requirement. Your office will continue to receive concerns because parents look forward to their child being in school. This amounts to a financial savings in daycare or freedom from not having to watch their child. We have continued to state that the first and foremost teacher of a child is his/her parent. Please allow these children to continue to have that extra year with their parents. Statistics will show that they have more to gain when they start school later.

In light of the aforementioned, we reiterate that we do not support Bill NO. 92.

Thank you for providing us the opportunity to be heard, as we also are your constituents.



AN ACT TO AMEND §6103 AND 6103.1 OF TITLE 17, GUAM CODE ANNOTATED RELATIVE TESTING FOR UNDERAGE ENTRANCE INTO KINDERGARTEN.

BE IT ENACTED BY THE PEOPLE OF GUAM:

3 Section 1. Section 6103 of Title 17 of the Guam Code Annotated is hereby4 amended to read:

"§6103. Children who Have Reached the Age of Five (5) Years Eligible 5 6 to Attend. Any child whose fifth birthday falls on or before the commencement date of classes may, in such year, enroll in the kindergarten of any public school 7 8 within the Territory which he is otherwise eligible to attend, except that any child 9 whose fifth birthday falls within one hundred twenty-five (125) days after the 10 beginning date of classes on the school calendar in the attendance area where they 11 live, and are designated to attend, may enroll in kindergarten, subject to the 12 approval of the principal of the school pursuant to the policy mandated by Section 13 3 of this Act §6103.1 of this Chapter.

14 The effective date of this Section shall be the start of school year 1998-1999."

Section 2. Section 6103.1 and Section 6103.2 of Title 17 of the Guam Code
 Annotated are hereby amend to read:

"§6103.1. Policy and Procedures. The Department of Education shall,
prior-to-the start of school-year 1998-1999, develop a policy and implement
procedures by which children, who will have reached the age of five (5) within
one hundred twenty-five (125) days after the beginning date of classes on the
school calendar in the attendance area where they live and are designated to attend
and whose parents or guardians so desire, will be screened to determine readiness
for school. Any such child whose parent(s) request screening for entrance into
kindergarten under the provisions of this section at least thirty (30) days prior to
the start of the school year shall be screened and upon passing, deemed eligible to
be admitted on a space available basis. Space availability shall be based on the
class size limits as determined by DOE policy. In the event that space is available
in a class but number of eligible students exceeds such space available, first
priority for admission shall determined based on the age beginning with the eldest.
