Dear Speaker Pangelinan:

Transmitted herewith is Bill No. 69 (LS), "AN ACT TO ADD SARS TO GUAM'S COMMUNICABLE DISEASE LIST, BY ADDING A NEW ITEM TO 10 GCA §3301(a)," which I signed into law on April 9, 2003, as Public Law 27-07.

SARS remains a very real threat to Guam given our proximity to Asia. Executive Order No. 2003-10 which I promulgated on April 7, 2003, began the process of providing our public health officials with the legal tools to prevent transmission of the disease. Executive Order 2003-10 also formed a Task Force to establish a coordinated response plan to the disease. I am pleased that *I Liheslaturan Guåhan* has also taken steps to address Guam's response to SARS by passing Bill No. 69. Bill No. 69 adds SARS to the list of statutorily identified communicable diseases that are dangerous to the public health. Consequently, pursuant to law, the Director of Public Health and Social Services can now take necessary forceful measures against the disease, including the quarantine of individuals carrying the SARS pathogen. We must remain vigilant as long as the disease poses a public health threat to Guam and the rest of the world.
