





**2004 (SECOND) Regular Session**

I, vicente (ben) c. pangelinan, Speaker of *I Mina' Bente Siete Na Liheslaturan Guåhan*, hereby certify, in conformance with Title 2 Guam Code Annotated §2103, *Public Hearings Mandatory*, as amended, that an emergency condition exists involving danger to the public welfare of the people and therefore waive the statutory requirements for a public hearing on Bill Number 225 (COR), "AN ACT TO APPROPRIATE FIVE MILLION SEVEN HUNDRED AND SEVENTY-ONE THOUSAND SEVEN HUNDRED AND SEVENTY-SIX DOLLARS (\$5,771,776) FROM THE GENERAL FUND FOR THE PURPOSES OF PROCURING NEEDED INSURANCE AND MEETING MATCHING CONTRIBUTIONS REQUIRED TO COMPLETE REPAIRS TO OUR SCHOOLS FUNDED BY FEMA, AND RELATED PURPOSES," which was introduced on this date, November 24, 2003, and therefore waive the statutory requirements for a public hearing on Bill Number 225 (COR).
