Dear Speaker Won Pat:

Transmitted herewith is Bill No. 346 (EC), "AN ACT TO AMEND §7113 OF CHAPTER 7, TITLE 17 OF THE GUAM CODE ANNOTATED, RELATIVE TO LIMITATIONS ON THE CAPACITY LEVELS FOR CONSTRUCTION OF NEW PUBLIC SCHOOLS; TO AMEND SECTION 2 OF PUBLIC LAW 29-102, RELATIVE TO EXPENDITURE OF BOND PROCEEDS; TO AMEND §3128 OF TITLE 17, GUAM CODE ANNOTATED, AND TO DELETE SECTION 11 OF PUBLIC LAW 28-183, RELATIVE TO EMPLOYMENT OF RETIREES AT GUAM PUBLIC SCHOOL SYSTEM (GPSS); TO APPROPRIATE FIVE MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$5,800,000) FROM THE GENERAL FUND FOR TEXTBOOKS; TO DIRECT THE PUBLIC AUDITOR TO AUDIT TEXTBOOK ACQUISITIONS AT GPSS; TO DIRECT I MAGA' LAHI TO RESERVE TWO MILLION DOLLARS (\$2,000,000) OF COMPACT IMPACT FUNDS FOR TEXTBOOKS; AND TO MAKE AN APPROPRIATION FOR THE CHILD NUTRITION PROGRAM, which was signed on August 22, 2008 as Public Law No. 29-106.

In our pledge to support the Guam Public School System in providing an adequate education to our public school children, I signed Bill No. 346 notwithstanding its inorganic provision pertaining to "compact impact" funds a rider that was placed on the measure without a public hearing. U.S. Public Law 108-188 governs and appropriates "compact impact" funds to Guam. Prior to awarding these funds, the Department of Interior must approve Guam's proposal detailing the project(s) to be funded. The provision to "earmark compact impact funds" ignores federal law including the Organic Act which prohibits the Legislature from appropriating what has otherwise been appropriated by Congress. The provision also impermissibly binds future governors by mandating the Governor to "earmark" these funds over the next four years. As such, the Administration will not violate these federal laws by implementing this particular provision.







AN ACT TO *AMEND* §7113 OF CHAPTER 7, TITLE 17 OF THE GUAM CODE ANNOTATED, RELATIVE TO LIMITATIONS ON THE CAPACITY LEVELS FOR CONSTRUCTION OF NEW PUBLIC SCHOOLS; TO *AMEND* SECTION 2 OF PUBLIC LAW 29-102, RELATIVE TO EXPENDITURE OF BOND PROCEEDS; TO *AMEND* §3128 OF TITLE 17, GUAM CODE ANNOTATED, AND TO *DELETE* SECTION 11 OF PUBLIC LAW 28-183, RELATIVE TO EMPLOYMENT OF RETIREES AT GUAM PUBLIC SCHOOL SYSTEM (GPSS); TO APPROPRIATE FIVE MILLION EIGHT HUNDRED THOUSAND DOLLARS (\$5,800,000) FROM THE GENERAL FUND FOR TEXTBOOKS; TO DIRECT THE PUBLIC AUDITOR TO AUDIT TEXTBOOK ACQUISITIONS AT GPSS; TO DIRECT *I MAGA'LAHI* TO RESERVE TWO MILLION DOLLARS (\$2,000,000) OF COMPACT IMPACT FUNDS FOR TEXTBOOKS; AND TO MAKE AN APPROPRIATION FOR THE CHILD NUTRITION PROGRAM.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §7113 of Chapter 7, Title 17, Guam Code Annotated, is hereby
3 *amended* to read:

4 **"§7113. Limitations on Capacity Levels for the Construction of**
5 **New Public Schools.** All public schools built on Guam *shall* be designed
6 and constructed for student enrollment capacity limits as follows:

- 7 (a) Elementary Schools: *not to exceed* eight hundred (800)
8 students;
- 9 (b) Middle Schools: *not to exceed* one thousand one hundred
10 twenty (1,120) students; and
- 11 (c) High Schools: *not to exceed* one thousand seven hundred
12 (1,700) students.

13 The school capacity limitations of this Section *shall apply only* to
14 school projects initiated after September 30, 1997. The GPSS may, subject
15 to the approval of the Guam Education Policy Board, *exceed* the capacity
16 limits set forth in this Section provided that such adjustment would *not*
17 endanger student and employee health and safety. These provisions *shall*
18 not apply to school campuses that are temporarily used for double sessions."

19 **Section 2.** Section 2 of P.L. 29-102 is *amended* to read:

20 **"Section 2.** Guam Public School System (GPSS) is authorized to
21 transfer, in increments of up to Five Hundred Thousand Dollars (\$500,000),
22 between items in Attachment A of P.L. 29-19. For each incremental
23 transfer of up to Five Hundred Thousand Dollars (\$500,000), GPSS *shall*
24 notify the Speaker of *I Liheslaturan Guåhan* five (5) days before such
25 transfer can be effective."

1 **Section 3.** *Amend* §3128 of Title 17, Guam Code Annotated, to read:

2 **"§3128. Eligibility for CATS Employee Status.** A former Guam
3 Public School System employee who resigned *or* retired from a position
4 defined in 1 G.C.A. §715 Item 12, (a) through (e) and (k) in good standing:

5 (a) who gave thirty (30) days' notice before leaving his
6 employment, may be employed as a CATS employee, *if*
7 he holds a current certification for the position; or

8 (b) prior to the effective date of this Act, may be employed
9 as a CATS employee, *if* he holds a current certification
10 for the position."

11 **Section 4.** *Delete* Section 11 of P.L. 28-183.

12 **Section 5.** The sum of Five Million Eight Hundred Thousand Dollars
13 (\$5,800,000) is hereby appropriated from the FY2009 General Fund Revenues
14 to the Guam Public School System for textbooks. Any unused amounts *shall*
15 revert within ninety (90) days to the General Fund. GPSS *shall* submit a report
16 on the status of this appropriation and corresponding expenditures to *I*
17 *Liheslaturan Guåhan* every thirty (30) days until all textbooks ordered with this
18 appropriation have been delivered to the students.

19 **Section 6.** The Public Auditor *shall* conduct a thorough financial and
20 management audit of textbook acquisition, use, processes, costs and
21 accountability at the Guam Public School System. The audit report *shall* be
22 submitted to *I Liheslaturan Guåhan*, *I Maga'lahen Guåhan* and the Guam
23 Education Policy Board *no later than* sixty (60) days after the enactment of this
24 law, and *shall* include specific recommendations for reforms.

25 **Section 7.** *I Maga'lahi shall* earmark a total of Two Million Dollars
26 (\$2,000,000) to support the purchase and payment of textbooks necessary to

1 meet the legal mandates of the Adequate Education Act for the Guam Public
2 School System from Compact Impact Reimbursement Funds over the next four
3 (4) years. *I Maga'lahi* is authorized to borrow money to meet the immediate
4 ordering of textbooks for GPSS, which loan can be repaid from the Two Million
5 Dollars (\$2,000,000) earmarked from the Compact Impact Reimbursement
6 Funds.

7 *If I Maga'lahi* funds the purchase of the required textbooks from another
8 source, this Section *shall* be null and void, including the authority to borrow.

9 **Section 8.** The amount of Two Million Nine Hundred Seventy-one
10 Thousand Thirty-four Dollars and Seventy-five Cents (**\$2,971,034.75**) is hereby
11 appropriated from the FY 2009 General Fund revenues to GPSS for payment of the
12 outstanding Commodity Invoices for Defense Logistics/DSCP for the Child
13 Nutrition Program.

RE: Request for Emergency Certification of Bill 346


I am requesting that Bill 346 be declared an emergency for the purpose of waiving the public hearing requirements.

Bill 346 is a bill that would allow the Superintendent of the Guam Public School System, with approval by the Guam Education Policy Board, to adjust upward the student enrollment capacity limits of schools constructed after September 30, 1997, so long as the school system can show substantial cost savings and that the adjustment will not negatively impact the health and safety of students and employees.

As you may be aware, the public schools are set to open on August 12, 2008. One of the challenges that the Superintendent is facing involves redistricting of students who will be attending the newly constructed As Tumbo Middle School located in Dededo. Current law does not allow her the flexibility to make adjustments to the enrollment capacity in order to maximize classroom utilization, as the capacities are fixed by law at a certain number. With the passage of this bill, those restrictions will be lifted and greater control will be given to the Superintendent to make those decisions.

I look forward to your approval of my request and the swift passage of this legislation.
