





AN ACT TO *ADD* §3333 TO ARTICLE 3, CHAPTER 3 OF TITLE 10 OF THE GUAM CODE ANNOTATED, RELATIVE TO RESTRICTING ENTRY INTO GUAM FOR INDIVIDUALS TRAVELLING FROM JURISDICTIONS DEEMED BY THE CENTERS FOR DISEASE CONTROL AND/OR THE WORLD HEALTH ORGANIZATION AS HAVING A HEALTH-RELATED OUTBREAK.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §3333 is hereby *added* to Article 3, Chapter 3 of Title 10 of the
3 Guam Code Annotated to read as follows:

4 **“§3333. Restricting Entry into Guam.** (a) Upon declaration by
5 the United States Centers for Disease Control and/or the World Health
6 Organization that a health-related epidemic *or* outbreak has taken place in a

1 jurisdiction, or issues a health advisory on a jurisdiction, *I Maga'lahren*
2 *Guåhan*, with the advice from the Director of Public Health and Social
3 Services, may, through Executive Order, declare a public health emergency
4 and restrict entry into Guam those individuals who have been in the affected
5 jurisdiction for *more than* one (1) week and do *not* possess a recognized and
6 certified document that attests that they have been tested for the specific
7 disease and determined *not* to be infected. The date of the test must *not* be
8 *more than* one (1) week from the date of their entry into Guam.

9 (b) Any individual who enters into Guam without the proper
10 documentation, *shall* be quarantined pursuant to this Section and §§19604
11 and 19605 of Article 6, Chapter 19 of Title 10, Guam Code Annotated.

12 (c) Any and all costs associated with the quarantine and/or
13 treatment of individuals who unlawfully enter Guam pursuant to this Act
14 will be the responsibility of the individual and the carrier that the individual
15 contracted to travel to Guam with.

16 (d) Once the entry restriction is imposed, it will remain in effect
17 until *I Maga'lahren Guåhan*, with the advice from the Director of Public
18 Health and Social Services, issues a written order rescinding the Executive
19 Order.”

Pursuant to 2 GCA §2103 and the Standing Rules of I Liheslaturan Guåhan, we hereby request that you declare that an emergency exists and allow Bill 351 to be placed on the Session Agenda.

As you know, our entry points of Guam are our lifeline to the rest of the world. We must be able to secure these entry points to insure the health and safety of our residents and visitors. Further, our island is fragile with regard to any infiltration of infectious diseases. We must not allow such infiltration and prevent individuals from entering our entry points that are carriers or even potential carriers of infectious diseases traveling from regions identified as such by the World Health Organization and the Centers for Disease Control.
