

**AN ACT TO ADD A NEW §26208.2 TO CHAPTER 26,
DIVISION 2 OF TITLE 11 OF THE GUAM CODE
ANNOTATED, RELATIVE TO THE PHARMACEUTICALS
FUND.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Amendment to Pharmaceuticals Fund.** A new §26208.2 is
3 hereby *added* to Chapter 26, Division 2 of Title 11 of the Guam Code Annotated, to
4 read as follows:

5 **“§26208.2 Application of Guam Memorial Hospital Authority**
6 **Pharmaceuticals Fund.** For the purpose of recognizing appropriated
7 Pharmaceutical funds as operating revenue by the Guam Memorial Hospital
8 Authority, retroactively and prospectively, the Hospital *shall* apply the funds

1 received towards the payment of bills for services incurred by qualified MIP
2 recipients involved in the program at the Hospital. Any funds remaining after
3 such payments *shall* be then applied to services provided to qualified recipients
4 enrolled in the Medicaid program by the Hospital. The Hospital will be
5 responsible to fully demonstrate the manner in which the payments were
6 applied via the Hospital's annual audited financial report. Such distinction
7 *shall* in no way result in the recognition of additional revenue by the Hospital
8 other than what was appropriated by *I Liheslatura*."
