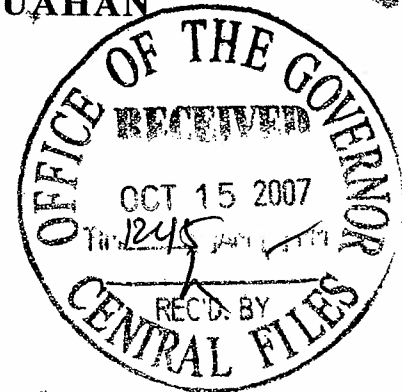



**AN ACT TO AMEND §79105 OF CHAPTER 79,
TITLE 12 GUAM CODE ANNOTATED,
RELATIVE TO FILLING VACANCIES IN THE
CONSOLIDATED COMMISSION ON UTILITIES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §79105 of Chapter 79, Title 12, Guam Code Annotated, is hereby
3 *amended* to read:

4 **“§79105. Vacancies.**

5 (a) A permanent vacancy in the Office of a Commissioner *shall*
6 be filled as follows:

1 (1) If the vacancy to be filled is for twelve (12) months
2 or more, the vacancy shall be filled by the next
3 highest vote-getter in the last General Election for
4 Commissioner.

5 (2) If the vacancy to be filled is for less than twelve (12)
6 months, the position shall remain vacant until the
7 next General Election.

8 For the purpose of items (1) and (2) in determining how many
9 months remaining on the vacant position, the effective date of vacancy
10 *shall* be the date from which to measure the months remaining, and not
11 the date when the vacancy is actually filled.

12 (b) The vacancy being filled under this provision will be for the
13 remaining balance of the term of the vacated position.”
