AN ACT TO ADD A NEW §15113 TO CHAPTER 15, TITLE 17, GCA, RELATIVE TO THE STUDENT SCHOLARSHIPS, FINANCIAL ASSISTANCE PROGRAMS AND ITS PROGRAM ADMINISTRATION AT THE UNIVERSITY OF GUAM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new §15113 is hereby *added* to Chapter 15 of Title 17 Guam Code Annotated to read as follows:

"§15113. Funding Priority. The President of the University of Guam shall allocate any and all appropriations made to the Student Scholarships, Financial Assistance Programs to those mandated by law in this Chapter prior to funding any other student scholarships or financial assistance programs that may have been created by the Board of Regents of the University of Guam."
