**AN ACT TO ADD A NEW §15113 TO CHAPTER 15, TITLE 17,  
GCA, RELATIVE TO THE STUDENT SCHOLARSHIPS,  
FINANCIAL ASSISTANCE PROGRAMS AND ITS PROGRAM  
ADMINISTRATION AT THE UNIVERSITY OF GUAM.**

1       **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2       **Section 1.** A new §15113 is hereby *added* to Chapter 15 of Title 17 Guam

3 Code Annotated to read as follows:

4               **“§15113. Funding Priority.** The President of the University of Guam  
5       *shall* allocate any and all appropriations made to the Student Scholarships,  
6       Financial Assistance Programs to those mandated by law in this Chapter  
7       *prior* to funding any other student scholarships *or* financial assistance  
8       programs that may have been created by the Board of Regents of the  
9       University of Guam.”
