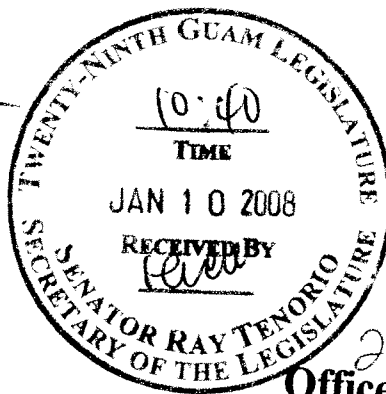

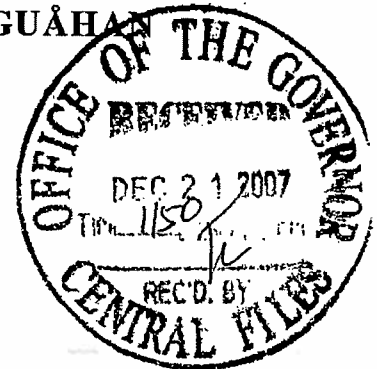

**AN ACT TO *ADD* A NEW §847 TO TITLE 1 GUAM CODE ANNOTATED, TO NAME THE LEGISLATIVE SESSION HALL AS THE “SPEAKER ANTONIO R. UNPINGCO LEGISLATIVE SESSION HALL.”**

1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1.** A new §847 is *added* to Title 1 Guam Code Annotated, to read  
3 as follows:

4           **“§847. Speaker Antonio R. Unpingco Legislative Session Hall.**  
5           The room designated by *I Liheslaturan Guåhan* (the Guam Legislature) as  
6           the location where legislative session is convened *shall* hereafter be known  
7           as the “Speaker Antonio R. Unpingco Legislative Session Hall.” From

1 funds allocated to the general operating budget of *I Liheslaturan Guåhan*, a  
2 plaque *shall* be permanently affixed to and maintained at the Session Hall's  
3 main entrance.”
