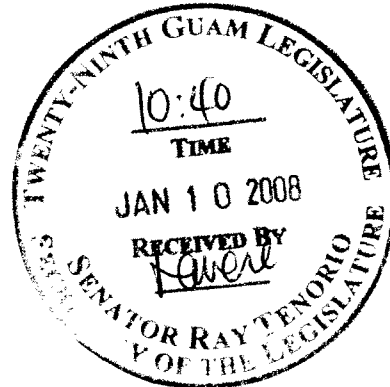

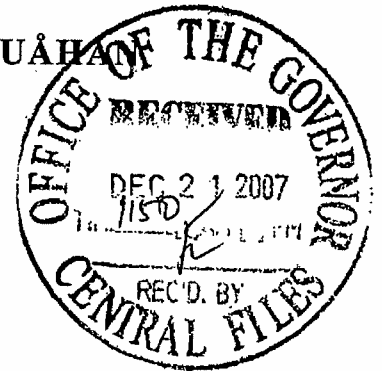

**AN ACT TO PLACE BLOCK NO. 5, BUILDING 125 IGLESIAS
CIRCLE, UNDER THE ADMINISTRATIVE JURISDICTION
OF THE MAYOR OF DEDEDO.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the Office of the Mayor of Dededo, the Guam Police Department Northern
4 Precinct, the Guam Fire Department, Station 4, originally shared the Municipal
5 building located on Block No. 5, Building 125 Iglesias Circle as shown in Land
6 Management Map No. 386-FY73. The Mayor's office relocated to the completed
7 Dededo Civic Center located on Block 3 as shown in Land Management Map No.
8 386-FY73 and the United States Postal Service leased the vacated space. The
9 Guam Police Department Northern Precinct and the Guam Fire Department,

1 Station 4 recently relocated to their new location at Lot No. 10155-6 and Lot No.
2 10155-7, Municipality of Dededo. The Dededo Mayor has expressed interest in
3 relocating the Dededo Mayor’s Office to its original location within the Dededo
4 Municipal Building.

5 The Dededo Mayor intends to offer its former office at the Dededo Civic
6 Center for use by various Dededo non-profit civic organizations which provide
7 youth and family oriented programs for the Dededo community. It is the intent of
8 *I Liheslaturan Guåhan* to transfer administrative jurisdiction of the Dededo
9 Municipal Building to the Mayor of Dededo.

10 **Section 2. Transfer of Property.** Administrative jurisdiction over the
11 Dededo Municipal Building located on Block No. 5, Building 125 Iglesias Circle,
12 Dededo, as shown on Land Management Map No. 386-FY93 is hereby transferred
13 to the Dededo Mayor, provided that the Mayor uses the existing facility for civic
14 and community purposes. Such purposes include, *but are not limited to*, a
15 community center, recreational use, and for other purposes determined by the
16 Dededo Mayor to improve the quality of life for the Dededo community.

17 **Section 3.** Item (7) of §40113 of Title 5 of the Guam Code Annotated is
18 hereby *amended* to read as follows:

19 “(7) The Mayor of Dededo is responsible for the *Astumbo* Recreation
20 Area, Central Park, the Civic Center, the Dededo Recreation Area and the
21 Dededo Municipal Building.”

22 **Section 4. Lease Agreement.** The existing Lease Agreement of the
23 Dededo Municipal Building by the United States Postal Service will continue to be
24 in effect.
