AN ACT TO APPROPRIATE THE SUM OF EIGHT HUNDRED THOUSAND DOLLARS (\$800,000) FROM THE GENERAL FUND TO THE DEPARTMENT OF REVENUE AND TAXATION (DRT) FOR THE PURPOSE **OF FUNDING OVERTIME COSTS** AND THE **PURCHASE** OF COMPUTER **HARDWARE** AND SOFTWARE IN ORDER TO SPEED UP THE REVIEW AND PROCESSING OF INCOME TAX RETURNS SO THAT DRT CAN PAY OUT **FEDERAL FUNDS** RECEIVED RELATIVE TO THE **FEDERAL** STIMULUS PACKAGE IN A TIMELY **ECONOMIC** MANNER.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Appropriation. The sum of Eight Hundred Thousand Dollars

1	(\$800,000) is appropriated from the General Fund to the Department of Revenue
2	and Taxation (DRT) in order to speed up the review and processing of income tax
3	returns so that DRT can pay out the Federal funds received relative to the Federal
4	economic stimulus package in a timely manner. The appropriation shall be for the
5	following purposes:
6	(a) Four Hundred Fifty Thousand Dollars (\$450,000) for the
7	purpose of paying overtime for employees processing income tax
8	returns; and
9	(b) Three Hundred Fifty Thousand Dollars (\$350,000) for the
10	purpose of purchasing computer hardware and software.
