

**AN ACT TO *ADD* A NEW §849.1 TO ARTICLE 1 OF  
CHAPTER 8 OF TITLE 1, GUAM CODE ANNOTATED, TO  
NAME THE PLANT NURSERY BUILDING AT THE GUAM  
DEPARTMENT OF AGRICULTURE THE “DAVID JOSEPH  
TORRES LIMTIACO PLANT NURSERY BUILDING”.**

**BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1. Legislative Intent.** In recognition of the significant contributions to the conservation, protection and enhancement of Guam’s vegetative environment and to the sustainability of its natural resources, specifically soil, water and air quality, it is the intent of *I Liheslaturan Guåhan* to name the new plant nursery building at the Guam Department of Agriculture the

1 “David Joseph Torres Limtiaco Plant Nursery Building” after Mr. David Joseph  
2 Torres Limtiaco, who passed away on February 8, 2008, and who had served as  
3 Chief of Forestry within the Forestry and Soil Resources Division of the Guam  
4 Department of Agriculture.

5 **Section 2.** A new §849.1 is hereby *added* to Article 1 of Chapter 8 of Title 1  
6 of the Guam Code Annotated to read:

7 **“§849.1. David Joseph Torres Limtiaco Plant Nursery Building.**

8 The new plant nursery building at the Guam Department of Agriculture is  
9 named the “David Joseph Torres Limtiaco Plant Nursery Building” in honor  
10 of David Joseph Torres Limtiaco, who served as the Chief of Forestry at the  
11 Forestry and Soil Resources Division of the Guam Department of  
12 Agriculture.”
