Dear Speaker Won Pat:

Transmitted herewith is Bill No. 34 (COR), "AN ACT TO AMEND §2108 OF TITLE 2, GUAM CODE ANNOTATED, RELATIVE TO CONSIDERATION OF BILLS BEFORE I LIHESLATURA (THE LEGISLATURE)", which was signed on March 13, 2009 as Public Law No. 30-02.

Although I have signed Bill No. 34(COR) into law, it seems unnecessary and a tenuous means to Restrictions on legislative actions are normally stated in a control legislative conduct. constitution or as in Guam's case the organic act. In order for legislative restrictions to have meaningful force and effect, it would need to be contained in a law that could not be changed by a majority vote of the Guam legislature. Provisions for the consideration of bills would seem more appropriate in legislative standing rules. As a result, this law will be added to many others on the books that are subject to legislative waivers.

AN ACT TO AMEND §2108 OF TITLE 2, GUAM CODE ANNOTATED, RELATIVE TO CONSIDERATION OF BILLS BEFORE I LIHESLATURA (THE LEGISLATURE).

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §2108, Title 2, Guam Code Annotated, is hereby *amended* to read:

"§2108. Separate Consideration of Unrelated Matters. (a) Any bill introduced, considered or passed by I Liheslaturan Guåhan, or any of its Members, shall not contain more than one (1) subject matter, and shall not contain unrelated subjects or pertain to multiple projects, except for one (1) annual budget bill and one (1) supplement to the annual budget bill per fiscal year; except that, the succeeding Liheslaturan Guåhan may, on the year it

commences, introduce, consider and pass one (1) supplement to the annual budget bill for that fiscal year, whose subject and contents *may* be *exempted* from this Section. Unrelated subjects on an annual budget bill *or only* one (1) supplement to the annual budget bill *shall* be the same subject matter as a bill which has been discussed at a duly noticed public hearing, unless the public hearing is waived due to the existence of emergency conditions involving danger to the public health *or* safety consistent with §2103, Title 2, Guam Code Annotated."

COMMITTEE REPORT

BILL NO. 034 (COR) - V.C. Pangelinan: AN ACT TO AMEND TITLE 2 GCA § 2108 RELATIVE TO CONSIDERATION OF BILLS BEFORE THE LEGISLATURE.

A public hearing was conducted by the Committee on Rules, Natural Resources and Federal, Foreign & Micronesian Affairs on the above titled subject on February 3, 2009 at 9:00 a.m. at the public hearing room of *I Liheslaturan Guåhan*, 155 Hesler Place, Hagåtña, Guam. Present at the hearing were the following Senators: Chairperson Rory J. Respicio, Vice Chairperson Judith P. Guthertz, Frank B. Aguon Jr., Adolpho B. Palacios, Vicente C. Pangelinan, Matt Rector and Telo Taitague.

BILL NO. 034 (COR) DIGEST: Introduced on January 6, 2009, Bill No. 034 (COR) amends § 2108 of Title 2 Guam Code Annotated to require that unrelated subjects placed on an annual budget bill or a supplement to the annual budget bill shall have been discussed at a duly noticed public hearing, unless the hearing was waived due to an emergency declaration.

TESTIMONY DIGEST: No one signed in to testify and no testimony was presented at the hearing.

The author, Senator V.C. Pangelinan, made brief remarks, stating that Bill 34 was a move to present greater transparency by giving the public an opportunity to voice their opinions on non-germane matters that are placed as amendments on annual budget bills and supplements to annual budget bills. If they have not been publicly heard, or the hearing has not been waived due to an emergency, the subject matter of these non-germane amendments will not be allowed to be added on to such budget bills. Senator Pangelinan said that legislation had eliminated non-germane amendments from other bills and that Bill No. 034 (COR) would now cover all bills.

There being no testimony presented, Chairperson Respicio declared that Bill No. 034 (COR) was publicly heard and that written and electronic testimony would be accepted for ten working days following the hearing.


I would like to acknowledge my colleagues who courageously voted "no" on Committee on Rules Resolution No. 1. I joined with seven other senators in casting my "no" vote because the resolution's proposed change to our Standing Rules, if enacted, could be easily waived by eight votes. A far better way to impose this restriction would be to amend P.L. 24-160 that first authorized the use of "riders" in budget bills 12 years ago. Fortunately, the author of both Resolution No. 1 and P.L. 24-160 realized this and introduced Bill No. 34 (COR), which proposes to amend his public law.

I look forward to conducting a public hearing on this and other measures to increase transparency and improve the public's ability to follow the legislative process. Our goal should always be to ensure that the people know what we are doing, and that the legislative process is fair for all members. Some have said (and even editorialized) that voting against Resolution No. 1 was a vote against keeping the public informed. They are either forgetting or ignoring important facts and recent history. Please allow me to use my experience as an example:

As a member of the minority in the first year of the 29th Legislature, I introduced Bill 37 proposing to establish the Office of Finance and Budget for more accurate revenue forecasting; and Bill 42 to require oaths for those testifying on fiscal matters. These bills were intended to ensure more transparency by making improvements to the legislative process. Both were introduced in January of 2007, but neither was given a public hearing by my colleagues in the majority, even though they had several opportunities to do so. Fortunately, we were able to place both bills as amendments to supplemental budget Bill No. 74, which became Public Law 29-02 in May of 2007.

The amendments weren't made to "shut the people out of the process," nor was this done because "we don't think public opinion is necessary." This was the ONLY avenue available to get important legislation enacted to INCREASE transparency. If Resolution No. 1 had been in place at that time, those amendments would not have been allowed. Ironically, the budget process, and the Ways and Means chair, will benefit from these "riders."

In the 30th Legislature, Section 7.01 of the Standing Rules requires committee chairs to conduct hearings on every bill referred to them, or the authors will have the authority to conduct their own hearings. This change allows ALL bills to have their day before the people and does more for



transparency than any artificial or pointless restriction. Real transparency requires sensible action, and I will be acting to address several items in that regard.

As many of you know, it's not unusual for Senators, while in session or at a public hearing, to receive emails, text messages and phone calls from interested constituents. Technology now allows our actions to be monitored when we are in public meetings. Improvements in technology have improved transparency, but when the Legislature has burned the midnight oil to meet a budget bill deadline, we have been rightfully criticized for taking action when most people have retired for the evening. Our actions have given added meaning to the phrase "under the cover of darkness." To address this concern I have introduced Resolution No. 13 (COR) that will prohibit late night sessions.

Also of concern is that past Legislatures sometimes did not afford the Governor his customary 10 days to review budget bills. The Legislature was also not given any "cushion" after the Governor's action to revise or adjust the budget prior to its effective date. I have introduced Bill No. 44 (COR), which would require the Legislature to pass the annual budget bill by August 31st.

I will be conducting a public hearing on Bills 34 and 44, and Resolution 13 at 9 a.m. on Tuesday, February 3rd, in the Public Hearing Room. I am appealing for your support for these real, long-term efforts to provide meaningful transparency and accountability.

Section 1. Legislative findings and intent. I Liheslaturan Guåhan 2 finds that it has become common practice for the annual budget of the 3 Government of Guam to be passed so close to the end of a fiscal year that I4 Maga'lahi' is often not afforded 10 days to review the document. This 5 "budgetary brinksmanship" also leaves little time for I Liheslatura to 6 address any Executive Branch concerns with the annual budget prior to 7 8 implementation of the budget at the beginning of a new fiscal year. It is therefore the intent of I Liheslatura to set a deadline for passing 9

10 and transmitting annual budget bills to *I Maga lahi'* for his consideration, to
11 give *I Maga lahi'* adequate time to review the document, and also to permit
12 *I Liheslatura* adequate time to address any concerns *I Maga lahi'* may have
