

#### II. SUMMARY OF TESTIMONY

#### DISCUSSION

- Chairwoman Won Pat, who authored Bill 308-30 explained that the legislation is necessary because the Charter School Council does not have enough members to constitute a quorum and therefore cannot be called to order to begin accepting applications in January 2010 as prescribed in P.L. 29-140. The proposed legislation extends the deadline to March 2010.
- There being no more comments and questions on Bill 308-30, Chairwoman Won Pat concluded the discussion on the bill.

#### III. FINDINGS AND RECOMMENDATION

The Committee on Education to which Bill 308-30 (COR) was referred, finds support for the passage of the bill and hereby submit its findings and recommendations to *I Mina' Trenta Na Liheslaturan Guahan* **TO DO PASS** Bill 308-30(COR).



#### 1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. §12106 of Title 17 of the Guam Code Annotated is amended to read as follows:
- 4 §12106. Process for Approving or Denying Charter School Petitions.
  - (a) Schedule. An eligible applicant seeking to establish an Academy Charter School *shall* submit a petition pursuant to §12105 of this Chapter to the Council *no later than* the first Monday of January. However, it is recommended that an eligible applicant consult with the Council prior to submitting the petition. All petitions submitted *no later than* the first Monday in January *shall* be for the following school year. The deadline to submit a petition to establish a non-converted public school into an Academy Charter School or convert a public elementary school into an Academy Charter School for the school year 2010-2011 shall be March 8, 2010.
