



1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** §12106(a) of Chapter 12, Title 17, Guam Code Annotated, is
3 *amended* to read as follows:

4 “(a) Schedule. An eligible applicant seeking to establish an
5 Academy Charter School *shall* submit a petition pursuant to §12105 of this
6 Chapter to the Council *no later than* the first Monday of January. However,

1 it is recommended that an eligible applicant consult with the Council prior
2 to submitting the petition. All petitions submitted *no later than* the first
3 Monday in January *shall* be for the following school year. The deadline to
4 submit a petition to establish a non-converted public school into an
5 Academy Charter School *or* convert a public elementary school into an
6 Academy Charter School for the School Year 2010-2011 *shall* be March 8,
7 2010.”






- **Chairwoman Won Pat**, who authored Bill 308-30 explained that the legislation is necessary because the Charter School Council does not have enough members to constitute a quorum and therefore cannot be called to order to begin accepting applications in January 2010 as prescribed in P.L. 29-140. The proposed legislation extends the deadline to March 2010.

- There being no more comments and questions on Bill 308-30, Chairwoman Won Pat concluded the discussion on the bill.

III. FINDINGS AND RECOMMENDATION



BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. §12106 of Title 17 of the Guam Code Annotated is amended to read as follows:

§12106. Process for Approving *or* Denying Charter School Petitions.

(a) Schedule. An eligible applicant seeking to establish an Academy Charter School *shall* submit a petition pursuant to §12105 of this Chapter to the Council *no later than* the first Monday of January. However, it is recommended that an eligible applicant consult with the Council prior to submitting the petition. All petitions submitted *no later than* the first Monday in January *shall* be for the following school year. The deadline to submit a petition to establish a non-converted public school into an Academy Charter School or convert a public elementary school into an Academy Charter School for the school year 2010-2011 shall be March 8, 2010.
