

AN ACT TO *ADD* NEW SUBSECTIONS (e) AND (f) TO §75107 OF CHAPTER 75 OF TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO REQUIRING TWO (2) APPRAISALS OF ANY *CHAMORRO* LAND TRUST PROPERTY TO BE LEASED.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. New Subsections (e) and (f) are added to §75107 of Title 21,
- 3 Guam Code Annotated, to read:

- 4 "(e) The Commission shall require two (2) appraisals of any
- 5 commercial property to be leased or any license to be issued as authorized

by this Section. Appraisals *shall* be paid by the potential lessor or licensee, and at least one (1) appraiser *shall* be chosen by the Commission.

(f) Nothing herein *shall* be construed to authorize the commercial lease or the license of *Chamorro* Land Trust properties prior to the promulgation of rules and regulations, pursuant to the Administrative Adjudication Act or adoption by *I Liheslatura* (the Legislature), to govern commercial leases and licenses."
