

**AN ACT TO AMEND PARAGRAPH (i) OF § 3109 OF  
ARTICLE 1, CHAPTER 3 OF TITLE 16, GUAM CODE  
ANNOTATED, RELATIVE TO MOTORCYCLE  
LICENSE ROAD EXAMS.**

1        **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2        **Section 1.** Paragraph (i) of § 3109 of Article 1, Chapter 3 of Title 16,  
3        Guam Code Annotated, originally enacted as a new subsection of 3101(f) by  
4        Public Law 32-052:3, is *amended* to read:

5                “(i) No person may use a moped, scooter, or a  
6        motorcycle/motorbike with an engine size of one hundred fifty cubic

1 centimeters (150 cc) or smaller to take a qualifying road exam. A driver may  
2 operate a motorized two (2) or three (3) wheeled vehicle on public roads,  
3 with an engine size of one hundred forty-nine cubic centimeters (149 cc) or  
4 smaller; provided, that (A) the vehicle meets or exceeds U.S. Department of  
5 Transportation safety specifications for street operation; and (B) that the  
6 driver possesses a valid Class A operator's license or higher, or a valid  
7 motorcycle operator's license."
