AN ACT TO APPROPRIATE THE SUM OF FIFTY-THREE THOUSAND SIX DOLLARS (\$53,006) FROM THE REMAINING FUNDS NOT OBLIGATED PURSUANT TO PUBLIC LAW 32-065 TO THE GUAM POLICE DEPARTMENT TO PURCHASE MOBILE RADIOS FOR POLICE VEHICLES.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Appropriation.** Notwithstanding any provision of law, from
3 the funds appropriated but not obligated or expended pursuant to Public Law 32-
4 065, the sum of Fifty-Three Thousand Six Dollars (\$53,006) is hereby appropriated

1 to the Guam Police Department to purchase mobile radios for seven (7) police
2 vehicles procured in April 2014 and July 2014.

3 **Section 2. Reporting Requirement.** The Chief of Police *shall* submit a
4 report to *I Maga'lahen Guåhan* and *I Liheslaturan Guåhan* on a quarterly basis
5 following the enactment of this Act as to the obligations and expenditures of the
6 funds, detailing all transactions pertaining to funds appropriated herein.
