





AN ACT TO AMEND SUBSECTION (d) OF § 5204 OF ARTICLE 2 OF CHAPTER 5, TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO AUTHORIZING THE PROCUREMENT OF SPORTS EQUIPMENT AND SUPPLIES FOR YOUTH AND COMMUNITY SPORTS PROGRAMS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Subsection (d) of § 5204 of Article 2 of Chapter 5, Title 11,
- 3 Guam Code Annotated, is hereby *amended* to read:

"(d) Moneys remaining in the Fund, after maintaining the stated reserves for administrative expenses of this Act, *shall* be appropriated in the following manner in each fiscal year:

- (1) up to one third (1/3) of the available balance to the Mayors Council of Guam for the repair and construction of village recreational facilities, including community centers, and for the procurement of sports equipment and supplies, including, but *not* limited to, team sponsorships and uniforms. Funds may also be used to purchase equipment required to support community programs administered by village mayors;
- (2) up to one third (1/3) of the available balance to the Department of Parks and Recreation for the repair and construction of its facilities, and for the procurement of sports equipment and supplies; and
- (3) up to one third (1/3) of the available balance to the Department of Education for the repair and construction of its sports facilities, and for the procurement of sports equipment and supplies.
- (4) Not more than fifty percent (50%) of the amount authorized in Item (1), twenty percent (20%) of the amount authorized in Item (2), and twenty percent (20%) of the amount authorized in Item (3), respectively, of this Subsection for the repair and construction of village recreational facilities and for the procurement of sports equipment and supplies *shall* be used for the procurement of sports equipment and supplies, including but not limited to, team sponsorships and uniforms."
