AN ACT TO ADD A NEW SUBSECTION (c) TO § 3102, AND TO AMEND § 3122 OF CHAPTER 3, TITLE 3, **GUAM** CODE ANNOTATED, **RELATIVE** TO ALLOWING FOR VOTER PRE-REGISTRATION OF PERSONS AT LEAST SIXTEEN (16) YEARS OF AGE; REPORT AMENDING THE OF DEATHS AND **PROVISION.** 

## **BE IT ENACTED BY THE PEOPLE OF GUAM:**

- 2 Section 1. A new Subsection (c) is hereby *added* to § 3102 of Chapter 3, Title
- 3 3, Guam Code Annotated, to read as follows:
- 4 "(c) Notwithstanding the age requirements of Subsection (a) of this 5 Section, upon satisfactory proof of age, every person that meets all eligibility

requirements to register and is sixteen (16) years of age or older, may pre-1 2 register to vote. A properly executed registration made pursuant to this Subsection *shall* be deemed effective as of the date the affiant will be eighteen 3 4 (18) years of age, if the information in the affidavit of registration is still current at the time. If the information provided by the affiant is not current at the time 5 that the registration would otherwise become effective, the affiant must provide 6 7 current information by any means authorized in this Chapter for persons eighteen (18) years of age or older for the affiant's registration to become 8 9 effective."

Section 2. § 3122 of Chapter 3, Title 3, Guam Code Annotated, is hereby *amended* to read as follows:

## "§ 3122. Report of Deaths.

No later than the fifteenth (15th) day of each month, the Director of
Public Health and Social Services shall furnish the Commission with an
abstract of the register of deaths for all decedents sixteen (16) years of age and
over, showing the:

- 17 (a) full name;
- 18 (b) sex;
- 19 (c) date of birth;
- 20 (d) nativity/place of birth;
- 21 (e) home address; and
- 22 (f) month, day and year of death."

23 Section 3. Effective Date. This Act *shall* become effective upon enactment.
