**AN ACT TO APPROPRIATE THREE HUNDRED THOUSAND DOLLARS (\$300,000) FROM THE GUAM PRESERVATION TRUST FUNDS AUTHORIZED IN SECTION 2 OF PUBLIC LAW 33-19 TO THE DEPARTMENT OF PUBLIC WORKS FOR THE REPAIR OF THE *UMATAC* BRIDGE TOWERS IN ANTICIPATION OF THE 12<sup>TH</sup> FESTIVAL OF PACIFIC ARTS.**

**BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1. Appropriation.** Notwithstanding any other provision of law, the amount of up to Three Hundred Thousand Dollars (\$300,000) is hereby appropriated from the Guam Preservation Trust funds authorized in Section 2 of

1 Public Law 33-19 to the Department of Public Works for the repair of the *Umatac*  
2 Bridge Towers. This appropriation *shall not* lapse and *shall* remain available for  
3 the purpose identified herein until fully expended.

4 **Section 2. Reporting Requirement.** *No later than* thirty (30) days  
5 following the completion of repair work to the *Umatac* Bridge Towers, the  
6 Director of the Department of Public Works *shall* submit a report to the Speaker of  
7 *I Liheslaturan Guåhan* and to *I Maga'låhen Guåhan* detailing all expenditures  
8 made pursuant to the requirements of this Act and of Public Law 33-19.
