AN ACT TO APPROPRIATE THREE HUNDRED THOUSAND DOLLARS (\$300,000) FROM THE GUAM PRESERVATION TRUST FUNDS AUTHORIZED IN SECTION 2 OF PUBLIC LAW 33-19 TO THE DEPARTMENT OF PUBLIC WORKS FOR THE REPAIR OF THE UMATAC BRIDGE TOWERS IN ANTICIPATION OF THE 12TH FESTIVAL OF PACIFIC ARTS.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Appropriation. Notwithstanding any other provision of law,
 the amount of up to Three Hundred Thousand Dollars (\$300,000) is hereby
 appropriated from the Guam Preservation Trust funds authorized in Section 2 of

Public Law 33-19 to the Department of Public Works for the repair of the *Umatac* Bridge Towers. This appropriation *shall not* lapse and *shall* remain available for
 the purpose identified herein until fully expended.

Section 2. Reporting Requirement. No later than thirty (30) days
following the completion of repair work to the Umatac Bridge Towers, the
Director of the Department of Public Works shall submit a report to the Speaker of *I Liheslaturan Guåhan* and to *I Maga'låhen Guåhan* detailing all expenditures
made pursuant to the requirements of this Act and of Public Law 33-19.
