

**AN ACT TO AMEND § 1026 OF CHAPTER 10, TITLE 1,
GUAM CODE ANNOTATED, RELATIVE TO
ESTABLISHING THE GUAM LIBERATION DAY
FISHING AND SPORTING EVENTS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 1026 of Chapter 10, Title 1, Guam Code Annotated, is
3 *amended* to read:

4 **“§ 1026. Guam Liberation Day Fishing and Sporting Events.**

5 (a) There shall be a Guam Liberation Day Fishing and Sporting
6 Events held annually, which events *shall* be part of the Liberation Day
7 festivities, and *shall* be promoted as a tourist attraction for visitors to Guam
8 and as an outdoor recreational activity for the people of Guam. The Guam
9 Liberation Day Fishing and Sporting Events may include spearfishing and

1 shoreline fishing challenges, and surfing and paddling competitions. *I*
2 *Maga'låhen Guåhan* (the Governor) *shall* appoint a Guam Liberation Day
3 Fishing and Sporting Events Committee composed of fishermen, water
4 sports professionals, and other interested individuals, which Committee *shall*
5 choose annually a period for such fishing and sporting events and *shall* plan,
6 organize and promote the events in coordination with the Guam Visitors
7 Bureau. Following the selection of the dates by the Committee, *I*
8 *Maga'låhen Guåhan shall* issue a proclamation calling upon the sports
9 fishermen and water sports professionals of Guam and the Pacific region to
10 take part in this event.

11 (b) The Guam Liberation Day Fishing and Sporting Events Fund
12 (Fund) is created to be expended for the purposes of promoting and
13 operating the fishing and sporting events. The Fund *shall* be expended upon
14 authorization by the Guam Liberation Day Fishing and Sporting Events
15 Committee. The Guam Liberation Day Fishing and Sporting Events
16 Committee is authorized to accept donations and grants which *shall* be
17 deposited in the Fund. The sum of Thirty-five Thousand Dollars (\$35,000) is
18 hereby authorized from the Tourist Attraction Fund to the Guam Liberation
19 Day Fishing and Sporting Events Fund for the costs of promoting and
20 operating the Guam Liberation Day Fishing and Sporting Events. The
21 Committee *shall* report to *I Liheslaturan Guåhan* on the expenditure of all
22 funds for the fishing and sporting events. The report *shall* contain detailed
23 information on each expenditure, including the date of expenditure, the
24 amount and the purpose, and *shall* be submitted to *I Liheslaturan Guåhan* no
25 later than November 30 of each year.

26 (c) Clerical, technical and logistic support for the Guam Liberation
27 Day Fishing and Sporting Events *shall* be provided by the Guam Visitors
28 Bureau.”
