

**AN ACT TO ADD A NEW SECTION 18 TO PART I OF  
CHAPTER II OF PUBLIC LAW 33-66, RELATIVE TO  
APPROPRIATING AND DEPOSITING FY 2016  
TERRITORIAL EDUCATIONAL FACILITIES FUND  
REVENUES COLLECTED IN EXCESS OF TWENTY-  
NINE MILLION TWO HUNDRED FIFTY-FIVE  
THOUSAND SEVEN HUNDRED TEN DOLLARS  
(\$29,255,710) TO THE GUAM DEPARTMENT OF  
EDUCATION OPERATIONS FUND BANK ACCOUNT  
FOR FY 2016 GDOE OPERATIONS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

1           **Section 1.** A new Section 18 is hereby *added* to Part I of Chapter II of  
2 Public Law 33-66 to read:

3           “**Section 18.** Notwithstanding any other provision of law, rule, or  
4 regulation, except § 22425(q) of Article 4, Chapter 22 of Title 5, Guam  
5 Code Annotated, funds collected, recorded, and/or recognized during FY  
6 2016 in the Territorial Educational Facilities (TEF) Fund in excess of  
7 Twenty-Nine Million Two Hundred Fifty-Five Thousand Seven Hundred  
8 Ten Dollars (**\$29,255,710**) is hereby appropriated to the Guam Department  
9 of Education Operations Fund for Fiscal Year 2016 for GDOE operations.  
10 The Director of the Department of Administration *shall* deposit into the  
11 GDOE Operations Fund bank account, the sum of the TEF funds collected in  
12 excess of Twenty-Nine Million Two Hundred Fifty-Five Thousand Seven  
13 Hundred Ten Dollars (**\$29,255,710**) within five (5) days of the collection of  
14 said cash funds. Such deposits *shall* be in addition to the cash  
15 transferred/provided to the GDOE for the appropriations in Section 1 of this  
16 Part of this Chapter. The Director of the Department of Administration *shall*  
17 submit a cash remittance report to the Speaker of *I Liheslaturan Guåhan* no  
18 *later than* ten (10) days after the end of each month during Fiscal Year 2016,  
19 which *shall* include the aggregate amount collected, recorded, and/or  
20 recognized in the TEF Fund in excess of Twenty-Nine Million Two Hundred  
21 Fifty-Five Thousand Seven Hundred Ten Dollars (**\$29,255,710**) and the  
22 aggregate amount of such excess deposited into the GDOE Operations Fund  
23 bank account. It *shall* be a ministerial duty of the Director of the Department  
24 of Administration to make the deposits to the GDOE Operations Fund bank  
25 account as required by this Section. Notwithstanding any other provision of  
26 law, the appropriation in this Section *shall* continue to be available until  
27 fully expended and is *not* subject to transfer or use for any other purpose. §

1           1303 of Article 3, Chapter 1, Title 5 GCA *shall not* apply to the  
2           appropriation in this Section.”

3           **Section 2. Effective Date.** This Act *shall* become effective upon  
4           enactment.

5           **Section 3. Severability.** If any provision of this Act or its application to  
6           any person or circumstance is held invalid, the invalidity *shall not* affect other  
7           provisions or applications of this Act that can be given effect without the invalid  
8           provision or application and to this end the provisions of this Act are severable.
