



AN ACT TO AMEND § 106119(k) OF PART A OF ARTICLE 1, CHAPTER 106 OF TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO DEPOSITING ESCHEATED FUNDS IN THE HOUSING TRUST FUND FOR THE FIRST-TIME HOMEOWNER ASSISTANCE PROGRAM; AND TO AUTHORIZE THE TRANSFER OF FUNDS ELIGIBLE FOR ESCHEATMENT UNDER § 21116 OF TITLE 5, GUAM CODE ANNOTATED.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. § 106119(k) of Part A of Article 1, Chapter 106 of Title 11, Guam
- 3 Code Annotated, is hereby *amended* to read:

"(k) All funds transferred to the Treasurer of Guam pursuant to the provisions of this Section *shall* escheat to the government of Guam one (1) year subsequent to the date such transfers occurred. The Treasurer of Guam *shall* deposit such funds in the Housing Trust Fund established in Article 10 of Chapter 4, Title 12, Guam Code Annotated. Such funds *shall* be used in accordance with the provisions of the First-time Homeowner Assistance Program."

Section 2. Transfer Authority of Funds Eligible for Escheatment under § 21116 of Title 5, Guam Code Annotated. Notwithstanding any other provision of law, the sum of Seven Hundred Sixty-Four Thousand Nine Hundred Seventy-Five Dollars and Fourteen Cents (\$764,975.14), escheated to the General Fund prior to the end of Fiscal Year 2015, and available for appropriations in Fiscal Year 2015, pursuant to § 21116 of Chapter 21, Division 2, Title 5, Guam Code Annotated, *shall* be deposited in the Housing Trust Fund established in Article 10 of Chapter 4, Title 12, Guam Code Annotated. Such funds *shall* be used in accordance with the provisions of the First-Time Homeowner Assistance Program.
