

AN ACT TO ADD A NEW ITEM (11) TO SUBSECTION (m) OF SECTION 1, CHAPTER V OF PUBLIC LAW 33-66, RELATIVE TO PROVIDING AUTHORIZATION TO THE GUAM POLICE DEPARTMENT FOR OVERTIME PAYMENT OBLIGATIONS INCURRED IN PRIOR FISCAL YEARS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. A new Item (11) is hereby added to Subsection (m) of Section 1,
 Chapter V of Public Law 33-66 to read:
 "(11) Overtime Prior Year Obligations Authorized. The Guam
 Police Department is authorized to use funds from the appropriations made in
 - Subsection (m) of Section 1 of this Chapter V for the payment of prior year

1 obligations. I Maga'låhen Guåhan shall identify and transfer to the Guam 2 Police Department, from any appropriations in this Chapter V not restricted 3 from his transfer authority, the aggregate sum necessary for the payment of prior year obligations for overtime. The Director of the Bureau of Budget and 4 5 Management Research shall notify the Speaker of I Liheslaturan Guåhan no 6 later than five (5) days before such transfer is made; and shall include the 7 amount being transferred and the names of the department and/or agency, and 8 division of such department and/or agency, such appropriation is being 9 transferred from. Included in this notification to the Speaker of I Liheslaturan 10 Guåhan, the BBMR Director shall also certify that the appropriations being 11 transferred will *not* negatively impact the operations of the department and/or 12 agency from which appropriations are being transferred to the GPD. If such notification is not provided by the Director of the Bureau of Budget and 13 14 Management Research to the Speaker of I Liheslaturan Guåhan by the five 15 (5) working days prior to such transfer taking place as specified herein, such transfer authority shall not be authorized." 16
